**STRONG TO GALE FORCE WINDS IS EXPECTED TO AFFECT THE FOLLOWING AREAS:**

<b>THE EASTERN SEABOARD OF SOUTHERN LUZON</b> (Camarines Provinces, Catanduanes, Eastern coast of Albay, Eastern coast of Sorsogon, Eastern coast of Quezon including Polillo Island)	Cloudy skies with scattered rains	(45 - 63) / (24 - 34)	Rough to very rough	2.8 – 4.5
<b>THE EASTERN SEABOARD OF VISAYAS</b> (The Northern and Eastern Coasts of Northern Samar and the Eastern Coast of Eastern Samar)	Cloudy skies with scattered rainshowers and thunderstorms	(45 - 63) / (24 - 34)	Rough to very rough	2.8 – 4.5

Conduct press briefings as often as needed. This local effort will complement and reinforce efforts at the national level. Emphasis should be on proactive actions – evacuation rather than rescue.
