**STRONG TO GALE FORCE WINDS IS EXPECTED TO AFFECT THE FOLLOWING AREAS:**

<b>NORTHERN SEABOARD OF NORTHERN LUZON AND THE EASTERN SEABOARD OF NORTHERN AND CENTRAL LUZON</b> (Batanes, Calayan, Babuyan, Cagayan, Isabela and the northern coast of Ilocos Norte and Aurora)	Cloudy skies with scattered rains	(45 - 63) / (24 - 34)	Rough to very rough	2.8 to 4.5
<b>WESTERN SEABOARD OF NORTHERN LUZON</b> (Ilocos Sur, La Union, Pangasinan and western coast of Ilocos Norte)	Partly cloudy to cloudy skies with light rains	(45 - 63) / (24 - 34)	Rough to very rough	2.8 to 4.5

Conduct press briefings as often as needed. This local effort will complement and reinforce efforts at the national level. Emphasis should be on proactive actions – evacuation rather than rescue.
