1. Belated Report on Vehicular Incident in Bolosan District, Dagupan City, Pangasinan

A. Situation Overview:

- Around 7:45 PM on 22 January 2018, a vehicular accident (VA) transpired along Barangay Bolosan District, Dagupan City, Pangasinan involving a Honda Jazz and a Vista Kia Van.
- Investigation showed that the Jazz car is heading the city when the Kia Van overtook a bicycle and encroached part of the opposite lane resulting to a collision.
- Both vehicles incurred heavy damages resulting to casualties.

C. Actions Taken:

- Authorities present during the incident brought the casualties to the nearest hospital including Region 1 Medical Center.
- OCD RO1 on continuous monitoring in AOR.

2. Belated Report on Fire Incident at Bacoor City, Cavite

A. Situation Overview:

- At about 1005H, 24 January 2018, a fire broke out in a residential area in the vicinity of Kalye Tigas, Barangay Tabing Dagat, Bacoor City, Cavite.

- On or about 1020H, the 4th alarm was immediately raised upon the arrival of the ground commander of the local BFP.
- The fire was put under control on or about 1102H and declared fire out at about 1117H.
- No casualties reported.

B. Effects:

- An estimated 200 residential houses made of light materials were totally damaged by the incident.

C. Actions Taken:

- Bacoor Fire Station immediately responded to the incident. Imus, Dasmariñas, Rosario, Kawit, Cavite City, Noveleta and Silang fire stations also responded to the said fire incident.
- Bacoor City DRRMO evacuated the victims at the Tabing Dagat Covered Court (in front of Old City Hall) and Tabing Dagat National High School (at the back of the Old City Hall).
- Bacoor CSWDO is also closely monitoring the situation of the evacuees.
- OCD IV-A is closely coordinating with the Bacoor City DRRMO, Bacoor CSWDO, Cavite PDRRMO, DSWD IV-A and BFP for updates regarding the incident.
