**I. Vehicular Accident in Ibaan, Batangas**

**A. Situation Overview**

- At around 1240 PM 08 March 2018, a JAM passenger bus with plate number AAI 8102 was going northbound to Manila along KM92 in Brgy Malainin, Ibaan, Batangas when the driver lost control of its steering wheel causing the vehicle to swerve and flip on its side.

**B. Effects**

**Casualties**

- A total of eighteen victims, including the driver and conductor were injured due to the incident and were rushed by responders to Mary Mediatrix Hospital in Lipa City, Batangas for immediate medical treatment.

#### D. Actions Taken:

##### OCD-RDRRMC CALABARZON

- Coordinated with Ibaan MDRRMC, Batangas PDRRMC, PRO IV-A, DILG IV-A, and DOH IV-A for updates and situation monitoring of the incident.

##### Ibaan PNP

- Immediately responded to control the situation and investigate the accident together with Tanauan CDRRMO.

##### Private ERTs

- Responded to the incident and transferred the victims to the hospital.

## II. Vehicular Accident in San Pablo City, Laguna

#### A. Situation Overview

- At around 6:00 AM, 09 March 2018, a motorcycle was speeding along Maharlika Highway when it suddenly swerved to the opposite lane and hit an incoming bus.

#### B. Effects

##### Casualties

- The driver and two (2) passengers of the motorcycle were brought by responders to San Pablo District Hospital but were all declared dead on arrival.

#### C. Actions Taken

##### OCD-RDRRMC CALABARZON

- Coordinated with San Pablo CDRRMC, Batangas PDRRMC, PRO IV-A, DILG IV-A, and DOH IV-A for updates and situation monitoring of the incident.

##### San Pablo CDRRMO and San Pablo PNP

- Immediately responded to control the situation and investigate the accident.
