# I. SITUATION OVERVIEW

# A. CHRONOLOGY OF EVENTS AND TYPHOON TRACK

# 07 May 2015

 At 4:00 AM, The Typhoon east of Visayas has entered the Philippine Area of Responsibility (PAR) and "DODONG" named was maximum sustained winds of 130 kph and gustiness of up to 160 kph slightly intensified which moving West Northwest at 15 kph. Public Storm Warning Signal (PSWS) #1 was raised in Catanduanes. Camarines Camarines Sur, Albay, Sorsogon, Polilio Island and Northern Samar



# 08 May 2015

 Typhoon Dodong was located at 510 km East of Sorsogon City, intensified to 160 kph maximum sustained winds and gustiness of 195 kph and accelerated West Northwest at 22 kph. PSWS #2 was raised in Catanduanes

# 09 May 2015

- Typhoon Dodong was at 210 km Northeast of Virac, Catanduanes wth strength of 160 kph and gustiness of 195 kph moving West Northwest at 20 kph. PSWS #3 was raised over Cagayan, Isabela, and Northern Aurora.
- At 10pm, it intensified to 165 kph and gustiness of 200 kph moving Northwest at 18 kph

# 10 May 2015

- TY Dodong further intensified with maximum sustained winds of 185 kph and gustiness of up to 220 kph moving northwest at 20 kph. PSWS #4 was raised over Northeastern Cagayan, Batanes, Babuyan and Calayan Group of Islands
- It made landfall over Pananapan Point, Santa Ana, Cagayan at 4:45PM
- At 10PM, TY Dodong has weakened to 160 kph and gustiness of 195 kph moving north at 16 kph. Areas previously under PSWS #4 were lowered to PSWS #3

# 11 May 2015

- TY Dodong weakened further as it moved in a Northeast direction with maximum sustained winds of 110 kph and gustiness of up to 140 kph and accelerated Northeast at 35 kph.
- All Public Storm Warning Signals were lowered

# 12 May 2015

 TY Dodong exited PAR at 5:00 AM and the final weather bulletin was issued

# B. TYPHOON ANALYSIS

On 07 May 2015, 4:00 AM, the typhoon East of Visayas has entered the Philippine Area of Responsibility (PAR) and was named "DODONG". TY Dodong weakend as it moved towards Balintang Channel. It slightly intensified as it moved Northwest and made landfall over Pananapan Point, Santa Ana, Cagayan at 4:45PM, 10 May 2015. PSWS #4 was raised over Northeastern Cagayan, Batanes, Babuyan and Calayan Group of Islands.



TY Dodong stayed inside PAR for five (5) days from 07-11 May 2015 and reached

a maximum sustained winds of 185 kph near the center and gustiness of up to 220 kph on 10 May 2015, 4:45 PM as it made landfall over Pananapan Point, Sta. Ana, Cagayan. During its stay in the PAR, PSWS Number 4 was the highest signal hoisted.

# II. PRE-EMPTIVE EVACUATION

1. A total of **1,029 families / 3,803 individuals** were pre-emptively evacuated starting 09 May 2015 in the Provinces of Isabela and Cagayan:

# D. STATUS OF LIFELINES

# POWER SUPPLY

 Power interruption was experienced in the Municipalities of Gonzaga, Sta. Ana, Buguey, Sanchez Mira, Sta. Teresita, Calayan, and Ballesteros in Cagayan Province on 10 May 2015. Power supply was restored in the said areas on 11 May 2015.

# E. STATUS OF PORTS

# 1. SEA PORTS

a. The number of strandees peaked at 10,200 passengers, 33 vessels, 16 motorbancas, and 1,051 rolling cargoes on 09 May 2015 in various coast guard stations in Bicol, Southern Tagalog and Eastern Visayas Regions reported.

# 2. AIRPORTS

a. A total of six (6) flights of Cebu Pacific to/from Laoag and Tuguegarao were cancelled on 10 May 2015 due to the typhoon.

  - 08 May 2015, 10:30 AM, presided by the Chairperson of NDRRMC

  - 10 May 2015, at 10:00 AM, 2:00 PM, and 9:00 PM, presided by the Administrator, OCD and Executive Director, NDRRMC

# D. RESPONSE CLUSTER (TAB C)

- 1. AFP and PNP have assisted LGUs in the conduct of pre-emptive evacuation of 1,029 families / 3,803 individuals in the Provinces of Isabela and Cagayan.
- 2. In Benito Soliven, Isabela, 36 plantation workers of Bio-Ethanol Plantation were rescued by the PDRRMO supported by the 8<sup>th</sup> IB, Philippine Army on 10 May 2015, 8:05 AM.
- 3. The Province of Isabela reported no damages and casualties.
- Tactical Operations Group (TOG) 2, PAF, assumed operational control of two (2) helicopters from TOG 3, PAF effective 11 May 2015 for utilization in the planned conduct of Rapid Damage Needs Assessment (RDANA).
- 5. On 10 May 2015, OCD-RDRRMC II conducted RDANA in the Municipalities of Aparri, Buguey, Sta. Teresita, Gonzaga, and Sta. Ana, all in Cagayan Province to assess the damages incurred. RDANA Team was composed of representatives from AFP, PNP, DILG, DOH, DSWD, and OCD. The team reported that no significant damage was incurred in the Province of Cagayan.

  - Ensured that the basic resources are made available or are prepositioned in their respective DRRM Operation Center/Offices
  - LCEs as a matter of policy shall personally man or are present in their AORs and observe the DRRM Project Listo Manual for their preparations

# DILG VI

- a. Alerted the field offices to closely coordinate with LGUs, activate the LDRRMCs, and conduct pre-emptive actions
- b. Recommended all LGUs to take preparedness measures in accordance with "OPERATION LISTO" to all LGUs
- c. Placed operations center on alert status

#### DUGCAR

- a. Attended PDRA meeting at the OCD-CAR Operation Center
- b. Issued memorandum to all LDRRMCs/LGUs on their preparedness measures and activation of alert status
