INITIAL REPORT ON MARITIME INCIDENT IN SARANGGANI PROVINCE

Situation Overview:

- A maritime incident occurred when F/B San Jose Bayanihan, with seven (7) crew members onboard navigating en route to Balut Island collided with Superferry 20 from the Makar Wharf, General Santos City en route to Manila via Zamboanga City
- Six (6) of crew members of the fishing boat, namely: Jonito Mendoza, 52 years old; Rex Bulawin, 28 years old; Marjus Iramis, 20 years old; Joseph Tiones, 20 years old; Regalado Sender, 19 years old; and Bryan Inero, 17 years old, were rescued while the remaining crew member, Giovanni Buntong, 60 years old, died.

Actions Taken:

- SAR team of Saranggani, PCG and PNP Maritime Group immediately responded to the incident and brought the survivors to the General Santos City District Hospital for medical treatment
- The body of the dead crew member was brought to Labajo Funeral Homes
- PCG Gensan conducted an investigation with the survivors of F/B San Jose Bayanihan as to the cause of the collision and advised PCG Zamboanga to conduct an inquiry with M/V Superferry 20 re the same incident

FIRE INCIDENT IN BUKIDNON

Situation Overview:

- On or about 10:30 AM 17 November 2011, a fire incident occurred in Lunsayan St., Brgy. Sumpung, Malaybalay City, Bukidnon
- The fire damaged four (4) residential houses. Three of the houses are owned by Mr. And Mrs. Salvador Daholuran, Sr. and the remaining house is owned by Salvador Daholuran, Jr.
- One person, namely Timothy Roach, was injured in the incident
- Estimated cost of damage due to the fire is PHP 500,000

Actions Taken:

- One Fire truck of the BFP Malaybalay responded to the incident
- Malaybalay Fire Station is still investigating the cause of the fire

FIRE INCIDENT IN ILIGAN CITY**Situation Overview:**

- On or about 10:30 AM 17 November 2011, a fire incident occurred in P-4, Brgy Saray, Iligan City.
- Two residential buildings owned by one Lolita Jamao were damaged by the fire, which was said to have started in the bedroom occupied by one Claudio G. Derecho.
- Estimated cost of damage due to the fire is PHP 15,000.00

Actions Taken:

- One Fire truck of the BFP Iligan responded to the incident
- Iligan Fire Station is still investigating the cause of the fire

VEHICULAR ACCIDENT IN CAGAYAN**Situation Overview:**

- On or about 5:00 AM 18 November 2011, a passenger van reported to have carried seven (7) passengers bound for Sta Ana fell into the Pared River in Barangay Assau, Baggao, Cagayan
- None of the passengers, including the driver, have been found

Actions Taken:

- Rescue 116 of Baggao and Rescue 29 of PDRPMC Cagayan were dispatched to the area to conduct search and retrieval operations
