### **A. Vehicular Accident along Gaogao, Tabuk City of Cordillera Autonomous Region**

#### **Situation Overview**

- On or about 8:45 AM 07 March 2012, a Ford Fiera vehicle carrying sixteen (16) passengers including the driver with plate number ADH 138 bound for Balbalsang, Balbalan, Kalinga fell down on a sharp curve at Gaogao, Tabuk City resulting to the death of one passenger.
- Initial investigation by the Provincial Health Emergency Services disclosed that the vehicle was overloaded with baggage. The victims suffered contusions, abrasions, minor wounds, trauma and fracture.

#### **Actions Taken:**

- Kalinga Rescue Emergency Services, Kalinga BFP and PDRRMC responded to the area
- OCD-CAR still monitoring for progress report

### **B. Fire Incident in Malabon City of National Capital Region**

#### **Situation Overview**

- On or about 3:55 PM, 06 March 2012, a fire incident occurred at Sitio 6, Brgy. Catmon, Malabon City which reached the 3<sup>rd</sup> alarm before it was declared under control and eventual fire out at 4:48 PM and 5:45 PM respectively.
- The fire started on the 2<sup>nd</sup> Floor of a two (2) storey residential house occupied by a certain Jennielyn Nokubo which spread out burning twenty other houses with an estimated damages of more or less P500,000.00 and affecting at least thirty (30) families
- A certain Yuchi Nokubo, 3 years old, was the lone fatality on the said incident.

#### **Actions Taken:**

- BFP Malabon City and other fire volunteers responded to the scene
- OCD-NCR coordinated with BFP Malabon City and requested for Spot Report

### C. Fire Incident in Mandaluyong City of National Capital Region

#### Situation Overview

- On or about 10:40 PM, 05 March 2012, a fire incident at Blk 37, Panatag Road, Acacia Lane Ext., Mandaluyong City and had reached the 4th Alarm before it was declared Fire Under Control and Fire Out at 11:20 PM and 11:50 PM respectively.
- The cause of fire is under investigation and the estimated damages runs from more or less P200,000.00.
- A certain Godofredo Mangubat suffered minor burns at his right hand and toes.

#### Actions Taken:

- Coordinated with Fire district 4 and requested for Spot Report
- OCD-NCR prepared and submitted final report of the aforesaid incident to NDRRMC Open

### D. Displacement Due to Armed Conflict in Region XII

#### Situation Overview

- On or about 9:45 AM 04 March 2012, affected families in Makilala, North Cotabato had to evacuate due to the armed conflict between government troops and the NPA rebels.

- Local DRRMC together with DOH/CHD XII provided relief assistance to the IDPs
