A. Vehicular Accident at Urdaneta City, Pangasinan

Situation Overview

- A vehicular accident occurred on or about 11:00 PM March 29, 2012 at National Highway, San Vicente Central, Urdaneta City, Pangasinan involving a Trailer Truck bearing plate number PSA 605 driven by a certain Dante L. Ciales, resident of 273 Calipahan, Talavera, Nueva Ecija and a Honda TMX 155 motorcycle bearing plate number RBA-471, driven by Mr. Oliver Velasco with two passengers.
- Investigation revealed that the motorcycle encroached the other side of road directly opposite the approaching truck and made a head on collision.
- As a result, the motorcycle was heavily damaged while its three (3) passengers suffered fatal injuries resulting to their death. The driver of the truck and lone passenger were injured as a result of the incident.

Action Taken:

- All the victims were brought to Undaneta District Hospital.
- The case is still under investigation.

B. Drowning Incident in Dagupan City, Pangasinan

Situation Overview

- On or about 07:05 PM 29 March 2012, a drowning incident was reported by Dagupan Police Station involving a certain Carlos T. Pabustan, 26 years old and resident of San Jose, Tarlac.
- Inquiry revealed that the group of the victim was celebrating a victory in a basketball tournament and decided to have a drinking spree at Tondaligan Beach in Dagupan City.
- The victim however went swimming and was later discovered to be missing. The body of the victim was later recovered at about 11 AM of the following day.

Actions Taken:

- The PNP Maritime and Dagupan City Police Station conducted SAR operations
