### **A. Fire Incident in Mandaluyong City**

#### **Situation Overview**

- On or about 0815H, 6 April 2012, a fire incident involving a residential area occurred in A. Luna St., Brgy. Burol, Mandaluyong City. The authorities declared fire out at 0926H. An estimated of 5 houses with 10 families were affected. The cause of fire and damages are still under investigation. There were no reported casualties.

#### **Actions Taken:**

- BFP Mandaluyong, PRC Rizal, and other fire volunteers responded to the incident
- OCD-NCR coordinated with BFP Mandaluyong for the initial information and for the spot report
- Affected families temporarily sheltered at the Brgy. Hall
- Local Government provided assistance to affected families

### **B. Electrocution in Bantay, Ilocos Sur**

#### **Situation Overview**

- On or about 0515H, 06 April 2012, Richard Castillo/17yo, a resident of Brgy. Capangdanan, Bantay, Ilocos Sur, accidentally held an untapped live joint of an extension wire which caused his immediate death

#### **Actions Taken**

- The case is still under investigation
- OCDRC1 is monitoring the incident

### **C. Progress Report re Explosion Incident in El Nido, Palawan**

#### **Situation Overview**

- On or about 5:30 PM, 05 April 2012, an explosion incident occurred in front of Entalula Beach Resort, Zone 3, Brgy. Masagana El Nido, Palawan that resulted to one (1) injured named: Aiza Gay Martinez Mallari, 25 yrs.old, cook of the said resort. Initial investigation revealed that the victim was throwing garbage outside the resort when the explosion took place.

## **Actions Taken**

- Victim was brought to Dr. Reyes Clinic at Brgy. Corong-Corong, El Nido, Palawan for medical treatment
  - El Nido MPS led by Pl Insp Analyn Palma proceeded to the scene with the EOD and Joint Task Force Malampaya to conduct investigation for possible identification of the type of explosive device.
  - PSSupt Reynaldo Jagmis, Provincial Director, immediately dispatched the Palawan PPO EOD Team and SOCO Team of Palawan Crime Laboratory Office in the crime scene.
  - Coordinated with WESCOM, AFP for possible tactical reinforcement.
  - **On 0600H, 06 April 2012, joint elements of Bomb Disposal Unit PPO and Palawan Crime laboratory office led by PCI Mary Jane B. Cordero conducted full blast investigation and crime scene operation at the crime scene. The team recovered the following items to wit:**
    - **Positive and negative terminal of nine (9) volts Eveready battery**
    - **Metal case nine (9) volts battery**
    - **Metal case of cell phone**
    - **Leg wire**
    - **Pink and yellow plastic bags (used as container of IED).**
