1. Maritime Incident (Capsized Boat) in Brgy. San Roque, Corcuera, Romblon

SITUATION OVERVIEW

- On or about 1:00 PM, 24 April 2012, a small fishing boat capsized with three (3) boxes of fish and two (2) passengers namely; Jesus Fanoga, 36 years old and Eric Fallarcuna, 24 years old, both residents of Brgy. San Roque, Corcuera, Romblon.
- Personnel from the Corcuera Municipal Police Station were conducting seaborne patrol when they chanced upon the fishermen who were rescued and were brought to the municipal clinic of the Municipality for medical treatment.

ACTIONS TAKEN

OCD/RDRRMC IV-B coordinated with PDRRMO Romblon regarding the incident

2. Shooting Incident in Barangay, Recodo, Zamboanga City

SITUATION OVERVIEW

- On or about 4:00 PM, 26 April 2012, a shooting incident occurred at Purok 8, Barangay Recodo, Zamboanga City.
- Joint elements of the Regional Intelligence Division (RID), PRO 9, Intelligence Section of Zamboanga City Police Office (ZCPO), RPSB9 PNP SAF, PCTC 9, RCIDU9 and PDEA 9 engaged in a shootout with drug dealers/pushers while serving a warrant of arrest to one Margami Samla a.k.a. Bin Laden. The suspect however had evaded arrest.

ACTIONS TAKEN

- PNP elements of ZCPO together with other forces are continuously conducting hot pursuit/manhunt operations against the suspected drug pusher.
- BDC-BDRRMC temporarily housed the IDPs at Recodo Barangay Hall while others were monitored to be staying with their relatives.
- CSWDO Zamboanga City conducted assessment and extended food assistance to the affected families.
- Responding Agencies from ZCPO, Ayala Police, Bomb Squad, Task-Force Zamboanga, Red Cross and ZCMC-HEMS are on standby to prevent escalation.
- Mayor Celso L. Lobregat and other City Officials visited scene site.
- OCD-RC OPCEN 9 is continuously monitoring the situation for any development.

3. Ambush in Tinoc, Ifugao

SITUATION OVERVIEW

 On or about 8:40 AM, 25 April 2012, elements of the 86IB, 51 ID PA led by LT. COL. Eugenio Batara were ambushed by undetermined number of CNN under a certain Ka Peter.
