1. Final Report re- Robbery/ Hold -up Incident in Quezon City

SITUATION OVERVIEW

 On or about 5:30 and 7:30 pm of 27 April 2012 a robbery/hold up occurred along Regalado Avenue cor. Ipil St. and Quirino Hiway beside Access Computer School, Brgy Lagro, Quezon City involving a passenger jeepney with a plate number TXM 574 and PWW 647

2. Progress Report re- Flashflood in Pilan River Zone 4 Sta. Cruz, Davao del Sur

I. SITUATION OVERVIEW

- On or about 7:30 PM of April 26, 2012 a flashflood occurred at Poblacion Zone 4, Sta.
 Cruz Davao del Sur due to overflow of Pilan River caused by continuous heavy rainfall
- Flood waters had already subsided as of 7:00 am of April 27, 2012
- No reported casualty

ACTIONS TAKEN

- Ongoing distribution of relief assistance to the evacuees
- PNP, BFP,10ID PA, SAVERS, PRC and MDRRMC conducted rescue operations and assisted in the evacuation of the affected population to the Municipal Gym
- MHO Sta. Cruz staff were at the area to aid the effected population
- LGU Sta. Cruz & Zone 4 Local officials facilitated the transfer of evacuees from the Municipal gym to the Barangay gym and GKK San Jose Chapel in Zone 4, Sta. Cruz, Davao del Sur
- LGU & MSWDO provided hot meals thru community kitchen, and distributed relief assistance from Phil. Red Cross and other donors

3. Fire in Makati City

SITUATION OVERVIEW

- At around 1620H 28 April 2012 a fire took place at a residential area in Camino dela Fe, Guadalupe Nuevo, Makati City. It reached its 1st alarm at 1622H and was declared fire out at 1639H
- Other information about the incident is still under investigation

ACTIONS TAKEN

- BFP Makati and Fire volunteers responded to the incident
- OCD-NCR coordinated with Makati FSTN for the initial investigation and requested for spot report
- OCD-NCR duty personnel monitored the situation
