1. RESCUED TWO (2) FISHERMEN AT BRGY. BABUYAN CLARO, CALAYAN, CAGAYAN

- On or about 11:25 AM, 25 June 2012, the tribal Chieftain of indigenous people of Babuyan Claro, Mr. Cruzaldo Rosales reported to the Coast Guard Station Aparri (CGS Aparri) that two (2) fishermen identified as, Mr. Jerry Brancano, 20 yrs old and Mr. Aniasco Bayong, 50 yrs old, both from Brgy. Mapid, Lagonoy, Camarines Sur, were rescued.
- The two fishermen sailed out to sea on May 30, 2012 onboard a 16HP gray banca at the vicinity waters of Parongparong, Catanduanes while there was a prevailing Active Low Pressure Area (ALPA) which developed into a Tropical Storm named "AMBO" and they were reported missing since 03 June 2012.
- The fishing banca encountered engine trouble while at sea and continuously drifted northward. They survived the three (3) weeks ordeal by eating algae and drinking rain water.
- At about 12:22 PM, 25 June 2012 CGS Camarines Sur reported to PDRRMC Camarines Sur that the two (2) fishermen are under the custody of Brgy. Chairman Alberto Dican at Brgy Babuyan Claro, Municipality of Calayan, Cagayan. The motorized banca boarded by the said fishermen is still intact but without fuel.
- **Actions Taken:**
 - CGS Camarines Sur provided the contact number of tribal Chieftain of Babuyan Claro, Cagayan to PDRRMO Camarines Sur
 - PDRRMO Camarines Sur reported that the two (2) fishermen drifting on sea at about 5kms from the shore of Barangay Claro were rescued by residents thereat.
 - OCDRCs 2 and 5 are closely coordinating with Coast Guard District North Eastern Luzon for the safe return of the two (2) fishermen to their families.

2. UPDATE RE LIGHTNING INCIDENT IN SAN MATEO, RIZAL

- On or about 2:30 PM, 25 June 2012, a lightning incident occurred **due to heavy rain** at Barandal Zuniega, Brgy. Sta Ana, San Mateo Rizal of Region 4A.

- PDRRMO Rizal and MDRRMO San Mateo responded to the incident.
- **OCD-RDRRMC IV-A coordinated with PDRRMO Rizal and MDRRMO San Mateo re the incident.**

3. INITIAL REPORT RE HALF-SUBMERGED MOTORIZED BANCA IN CORON, PALAWAN

- On or about 6:20 AM June 26, 2012, a certain Mr. Roberto Astor of Barangay Tagumpay, Coron, Palawan, skipper of motorized banca with markings 4 DELTA 2 owned by EN1 Danilo V. Ubalos of PCG reported to Coast Guard Coron (CG Coron) that while on fishing venture at the vicinity waters of Gintongan Island, Bulalacao, Coron, Palawan, sighted two (2) floating cadavers behind the half submerged motorized banca with markings "Princess Jessa" with registration number "LIN SN 001333".
- At about 7:00 AM June 26, 2012, CG Coron together with personnel of Special Operation Unit, Marine Environment Protection Unit, Field Station and ML Kalayaan departed onboard MBCA 4 DELTA 1, towed the said half-submerged motorized banca and retrieved the two (2) unidentified cadavers.
- Initial investigation by CGS Coron with PNP Coron showed that the two cadavers incurred 3rd degree burn and suspiciously hit by a lightning and identified as Toto Ranis and Jomar Dilao, both resident of Brgy. San Nicolas, Linapacan, Palawan.
- The cadavers were properly turned over to San Lorenzo Funeral Parlor of Coron, Palawan for autopsy and proper disposition.
- Under custody of CGS Coron for safekeeping and proper turned over to arriving family were recovered items, namely: cash amounting to Php42,587.00; one (1) plastic bunch bread; and, four (4) cellphones.

4. BELATED REPORT RE LIGHTNING INCIDENT IN NAVAL, BILIRAN

- On or about 4:00 AM June 25, 2012, a lightning incident occurred in Brgy. Atipolo, Naval, Biliran of Region 8 resulting to the death of one (1) person identified as Allan Escalla Casas, 48 yrs. old, married and a farmer.
- BLGU-Atipolo, Naval provided financial assistance worth one thousand five hundred pesos (Php1,500.00) to the family of the victim.
- Funeral services were shouldered by the Office of Congressman Rogelio J. Espina.
- OCDRC8 coordinated with Biliran PDRRM Officer Mr. Jun Dacillo regarding the incident.

5. UPDATE RE FIRE INCIDENT IN BRGY. CENTRAL, MATI CITY, DAVAO ORIENTAL

- On or about 8:45 PM, 24 June 2012, a fire incident **caused by an unattended lighted candle** occurred at Purok Nazareno, Purok Masagan 9 and Lopez Subd. of Brgy. Central, Mati City, Davao Oriental in Region 11. BFP with five (5) other fire volunteers declared fire out at 12:00 Midnight 25 June, 2012.
 - Estimated **80** families and **74** houses/commercial establishment were affected and **one (1) person, identified as Leoncio Z. Arreza, 41 yrs. old, died.**
 - **Cost of damage was estimated at PhP 20 Million**
 - **CDRRMC and PDRRMC together with CSWDO, CEO, CHO and Phil. Red Cross conducted validation and damage assessment.**
 - **CMDRRMC conducted an emergency meeting to recommend to the Local Sanggunian for the declaration of the State of Calamity in the three (3) Puroks.**
 - **ABS-CBN Davao and ABC 5 Davao extended food assistance to the fire victims.**
 - **Emergency Service Scouts and Red Cross Youth assisted in the relief food distribution.**
 - **Power was restored to normalcy at 10:00 AM June 26, 2012.**
 - Evacuation areas for the affected families were at Pelaez Activity Center, City Hall compound, Sambuokon Stage, Bay Walk Park. Others opted to stay with their relatives.
 - CSWDO Mati City conducted relief operations.
