1. REPORT re FIRE INCIDENT IN ESTANCIA, ILOILO

Situation Overview

- On or about 8:00 PM 08 October 2012, a fire broke out inside the Old Public Market of Estancia, Iloilo. Fifty (50) stalls were totally damaged. No casualties reported.
- Total estimated cost of damaged is Three Million Pesos (Php 3M). Cause of fire is still under investigation.

Actions Taken:

- Responded to the incident were Estancia, Balasan, Sara, Lemery, Barotac Viejo, San Dionisio, Roxas City, Pilar, Pontevedra, President Roxas, and Federation Fire Engine, Federation Rescue Vehicle and Federation Water Tanker.

2. FINAL REPORT re MISSING FISHERMAN IN ORAS, EAST SAMAR

Situation Overview

- On or about 4:00 AM 02 October 2012, two fishermen named Harry Ebron and Paquito Amos, both from Sta. Monica, Oras, East Samar, went offshore to go fishing but later in the afternoon of that same day their boat capsized. Mr. Amos managed to get to a near fishing vessel and was rescued by another fisherman while Mr Ebron was left in the capsized banca.
- On 03 October 2012, rescuers went offshore to rescue Mr Ebron but to no avail. Later, on 05 October 2012, Mr Ebron was rescued by a passing fisherman and was turned over to another fisherman from Borongan City.

Actions Taken:

- BDRRMC of Brgy. Sta. Monica conducted search and rescue operation for the missing fisherman and disseminated information to PNP and advised to take appropriate action.
- RDRRMC-OPCEN VIII coordinated with PRO 8 for possible SAR by PNP Eastern Samar.

3. REPORT re MALFUNCTIONED MOTORIZED BANCA IN BATUAN, MASBATE

Situation Overview

- On or about 11:55 AM 09 Oct 2012, a passenger motorized banca marked MBCA Wilbert experienced a malfunction in the propeller shaft which caused the engine to disengage. The incident happened in the vicinity waters of Mobo, Masbate, 3 kms from the shore of Masbate.
- The Banca is owned by Mr. Wilfredo B. Almenana, a resident of Brgy. Burgos, Batuan, Masbate. A total of 39 passengers were rescued safely.

Actions Taken:

- Coast Guard stationed in Masbate immediately conducted the SAR operation.

4. INITIAL REPORT re LIGHTNING INCIDENT IN KANANGA, LEYTE

Situation Overview

- An incident occurred wherein a grade 7 student identified as Kim Harold Pabio has been struck by lightning that caused him to be unconscious and was immediately brought to Kananga Municipal Hospital. The victim was transferred later to Ormoc District Hospital due to the formers lack of hospital facility.
- The report was made by Mayor Eric Codilla thru Acting Regional Director Rey Gozon. Latest report from Mayor Codilla revealed that the boy has already regained consciousness but is still in confinement for observation.

Actions Taken:

- OCD-VIII closely monitored the incident and the status of the victim. MDRRMC of Kananga facilitated the transportation of the victim to the aforementioned hospital.
