1. PROGRESS REPORT RE DISPLACEMENT DUE TO MULTIPLE LAND SLIDE IN SOUTH COTABATO

SITUATION OVERVIEW

- On 28 September 2012, multiple landslide incident occurred in South Cotabato displacing 109 families from Sitio Bentung, Lemuti, and Tokobokong al of Brgy Lamlahak, Lake Sebu.
- The incident was caused by almost a week of continuous normal rains in several ridges of the barren mountain slopes moved down in mass resulting to landslides.
- Residents evacuated into a safer place within the locality.
- 5 houses were totally damaged. A total of 83 families with 390 dependents have already vacated their homes. An estimated 20 hectares was affected, and an estimated Php 800,000.00 worth of crops and properties were damaged. Only 2 Sitios, namely Sitio Tokobukong and Bentung have evacuated.**

ACTIONS TAKEN:

- OCD XII and PDRRMC South Cotabato, MDRRMC of Lake Sebu and BDRRMC Lamlahak are currently conducting DANA.
- Local DRRMC extended relief assistance to the affected families.
- OCD XII and PDRRMC with DENR-MGB conducted meeting and scheduled to conduct technical assessment on 15 October, 2012

2. PROGRESS REPORT RE FOOD POISONING INCIDENT IN MAKILALA, NORTH COTABATO

SITUATION OVERVIEW

- On or about 8:30 AM, 10 October 2012, a food poisoning incident occurred in Makilala, North Cotabato
- The number of victims of food poisoning has increased to 131 persons.**

Actions Taken:

- **MDRRMC Makilala** facilitated the transportation and hospitalization of the victims, still on monitoring and conducting assessment on the total number of victims and verification of their names.
- OCD XII coordinated with the MDRRMC with regards to the situation of the area.

3. MISSING FISHERMEN IN ZAMBALES

Situation Overview

- **Nine (9)** fishermen aboard a twin engine boat "Jericho" were reported missing since 30 September 2012.
- All of the missing fishermen are from Sitio Lanao, San Agustin, Iba, Zambales.
- The missing fishermen are as follows:

Actions Taken:

- **MDRRMO Iba, Zambales** conducted Search and Rescue (SAR) operation and disseminated information re the missing fishermen along the coastal communities.
- **PNP and PCG Masinloc, Zambales** conducted survey in the area.
- **Personnel of CG Detachment Masinloc advised the Brgy. Officials and all fishery sectors of said municipalities to be on look-out for the missing fishermen and report to CG Station Subic if sighted.**

4. FIRE INCIDENT AT BRGY. MARCOVILLE, BAGUIO CITY

- **At around 11:00 AM 12 October 2012 a fire incident occurred just behind the Baguio Water District near the Office of Civil Defense-CAR.**
- **A total of 6 houses were razed by the fire.**
- **By 12:00 NN the fire was controlled and by 1:00 PM, fire out was declared by the Incident Commander.**

Actions Taken:

- **OCD-CAR assisted in the facilitation of the Crowd Control and Incident Management; provided a temporary holding area for children and the elderly at the regional office and distributed water and candies to the evacuees and displaced families; assisted in the emergency coordination with the Baguio City DRRMC-DOC.**
- **Baguio City DRRMC-DOC coordinated with their Council members and response teams for immediate and proper action.**

- Responders were Bureau of Fire Protection, PEZA Fire Department, Camp John Hay Fire Department, 911 On-Call, Baguio-Benguet Public Information and Civic Action Group, Baguio City Emergency Medical Services, Victory Liner Water, Baguio Water District and other water delivery services.
- Baguio City Police Office controlled the traffic.
- All evacuees returned to their homes and/or stayed with their relatives.

5. FIRE INCIDENT IN PASIG CITY

- At 3:34 PM 12 October 2012 a fire incident took place in 421B St. Paul St. SPS I Brgy. Rosario, Pasig City affecting 17 families.
- There were 12 houses burned.
- The fire reached 1st alarm, at 4PM the fire was under control, and declared fire out at 4:03 PM.
- Casualties:
 1. Mr. Jess Albay- 60 y/o
 2. Ms. Cecille Babon- 45 y/o
 3. Ms. Jeselle Babon- 17 y/o
- Cause of fire and cause of death of the said victims are still under investigation.

Actions Taken:

- OCD-NCR monitored the situation and requested for Spot Report from Fire District 4.
 - BFP-Pasig City responded to the incident.
