# 1. MISSING FISHERMEN IN LLORENTE, EASTERN SAMAR

#### SITUATION OVERVIEW

- On or about 4:00 PM, 11 October 2012, a fisherman, Julio Yape, onboard a small fishing vessel was reported missing.
- The 40 year old fisherman of Brgy Naubay, Llorente, Eastern Samar was last seen by a fellow fisherman at around 9:00 AM, 12 October 2012.
- The missing fisherman was rescued alive by a fellow fisherman at the coast of Maydolong Bay, Eastern Samar at about 6:30 AM, 13 October 2012. Julio Yape was brought home at around 7:00 AM on the same date.

### **ACTIONS TAKEN:**

- RDRRMC VIII OpCen continuously monitored the incident and coordinated with the Mayor's Office, MDRRMO Llorente, Llorente PNP and Eastern Samar Provincial Police Office.
- Llorente PNP and the Llorente Search and Rescue (SAR) team conducted SAR operation for the missing fisherman.

# 2. PROGRESS REPORT RE FLASHFLOOD INCIDENT IN LOBO, BATANGAS

### SITUATION OVERVIEW

- At about 6:30 PM, 10 October 2012, a flashflood incident occurred in Brgy. Nagtaluntong, Lobo, Batangas
- According to the investigation, an owner type jeepney carrying six (6) passengers
  was crossing a river along Barangay Nagtaluntong, Lobo, Batangas when a
  strong current swept the vehicle.
- One of the passengers was rescued and three (3) were recovered dead.
- At around 6:00 AM, 13 October 2012, the two (2) previously reported missing fishermen were found dead at Sitio Buhi, Brgy Tayuman, Lobo, Batangas.

# **ACTIONS TAKEN:**

- OCD IV-A coordinated with the MDRRMC Lobo, Batangas, 202nd IB and PCG-STL for information of the abovementioned incident.
- · AFP (SOLCOM), 202nd IB, PNP-LOBE and PCG-Southern Tagalog sent rescue team to assist the local rescuers in the area.
- MDRRMC Lobo thru MSWDO facilitated assistance to the bereaved families of the victims.
- MDRRMC Lobo put up an Incident Command Post and led the Search and Rescue operations.

# 3. VEHICULAR ACCIDENT IN VIRAC, ITOGON, BENGUET

#### SITUATION OVERVIEW

- On or about 5:20 PM, 12 October 2012, a jeepney carrying twelve (12) passengers tumbled sideways along Sito Anonang in Virac, Itogon, Benguet.
- · The passenger jeepney was traversing a narrow curved road when the driver, Fred Langgoyan Sr., lost contol after losing its breaks.
- · The victims sustained minor injuries and were sent home after getting medical treatment in Baguio General Hospital and Medical Center (BGHMC).

# 4. SHOOTING INCIDENT IN LAMITAN CITY, BASILAN

### SITUATION OVERVIEW

- At about 4:15 PM, 13 October 2012, three (3) Alpha Company 32IB personnel were shot to death by unidentified perpetrators in Brgy Baas, Lamitan City.
- Each of the enlisted personnel was on board a motorcycle when they were followed and fired at by the unidentified gunmen.
- The military personnel sustained multiple gunshot wounds which resulted to their death.
- The name of the military personnel are as follows:

  - 2. Cpl Adzhar A. Angkaya, PA
  - 3. PFC Radzmer A. Jasim, PA

#### **ACTIONS TAKEN:**

- OCD BASULTA coordinated with the 32IB for report confirmation.
- Lamitan City, Basilan Liaison Officer is continuously monitoring the incident for any developments
- . Local PNP and the 32IB conducted further investigation on the incident.
