1. Armed Conflict in Basilan

Situation Overview

- On or about 3:00 PM 05 November 2012, an ambush against the 545th Engineering Battalion (PA) occurred in Ungkaya, Pakan, Basilan.
- PFC Jahil Ahung was killed in action while two unidentified persons were wounded.
- Injured persons were transported to Lamitan City for medical treatment.

Actions Taken

OCD Basulta coordinated with the liason officer in Basilan for information and development of the said incident.

2. Final Report: Flash Flood in Misamis Oriental

Situation Overview

- On or about 7:00 PM, 28 October 2012, a flashflood brought about by heavy rains occurred and damaged the approach of the Tulay ng Pangulo at Digkalaan, Mapulog, Naawan, Misamis Oriental.
- It was reported that the bridge sustained damage worth P500,000.
- No casualty was reported in the said incident

3. Initial Report re Vehicular Accident in Quezon, Palawan

Situation Overview

On or about 12:00 PM, 05 November 2012, a vehicular accident involving a passenger bus occurred in Brgy. Tabon, Quezon, Palawan. The passenger bus lost control while travelling a curved road wherein twelve (12) passengers were brought to the Ospital ng Palawan. Five (5) of them were treated and sent home while seven (7) were admitted.
