1. PROGRESS REPORT: VEHICULAR ACCIDENT IN DOLORES, ABRA

SITUATION OVERVIEW:

- On or about 5:00 PM, 22 December 2012, the driver of an Isuzu dump truck lost control of the vehicle, bumped a tree then fell into a ravine along Abra Kalinga Road, Mudiit, Dolores, Abra.
- Twenty four (24)** persons sustained various injuries and were subsequently rushed to Abra Provincial Hospital for medical treatment.

ACTIONS TAKEN:

- **Abra Provincial Hospital** provided medicine and medical supply including tetanus vaccines.
- **Dolores Municipal Police, Abra PPO and other volunteer groups** responded to the incident.
- **OCD-CAR** coordinated with DOH-CAR for the status of the victims.

2. MISSING FISHERMEN IN SIKUIJOR

SITUATION OVERVIEW:

- On or about 3:00 AM, 22 December 2012, two (2) fishermen, identified as Billy Macalisang, Sr. and Billy Macalisang, Jr., went fishing off the sea of Barangay Catulayan, San Juan, Siquijor onboard a motorized banca.
- As of 6:00 PM, 23 December 2012, the two fishermen have not yet returned to their home.
- The ongoing search and rescue operations was called-off for the night and will resume tomorrow morning.

ACTIONS TAKEN:

- **San Juan Police Station, Municipal Bantay Dagat and MDRRMC** conducted search and rescue operations for the missing fishermen
 - **Siquijor Provincial DRRM Council** coordinated with the Philippine Coast Guard and the Office of Civil Defense
