### **I. INITIAL REPORT RE BOMBING INCIDENT IN ILIGAN CITY**

#### **SITUATION OVERVIEW:**

- On or about 10:05 AM 21 January 2013, an Improvised Explosive Device (IED) exploded between Oceana Pawnshop and M Lhuillier Pawnshop, Mercado Street, Iligan City, leaving a total of nine (9) casualties. Names of the casualties are as follows:

#### **ACTIONS TAKEN:**

- Injured victims were brought to Gregorio T. Lluch Memorial Hospital for treatment.
- Iligan Clty Police Office (ICPO) is still conducting an investigation to establish the identity of the perpetrators as well as the motive of the said incident.



## II. FINAL REPORT re DROWNING INCIDENT IN SURIGAO DEL NORTE

### SITUATION OVERVIEW:

- On or about 11:00 AM, 12 January 2013, a group of people went swimming along Bay River P-3 Brgy. Daywan, Claver Surigao del Norte. One of them went for a dive over a gabion and struggled. The rest followed attempting to rescue the victim but they were bashed by strong water current.
- Two (2) persons survived and three (3) persons were reportedly missing **and found lifeless, floating on the coastal areas of Surigao del Norte last 14 January 2013.**

### ACTIONS TAKEN:

- Search and Rescue/Retrieval Operation** were conducted by Local Government of Claver, Quick Action Response Team, Surigao del Norte, and other volunteer groups.
- OCD-CARAGA** is monitoring the incident.

## III. INITIAL REPORT ON DISPLACEMENT DUE TO ARMED CONFLICT

### SITUATION OVERVIEW:

- On 20 January 2013 at around 5:00 PM, an armed encounter transpired at Sitio Baumol, Brgy. Pidtiguain, Lambayong, Sultan Kudarat Province between the groups of Baumol Family and the group of a certain Commander Gani which resulted to four (4) injured victims and displacement of 208 families. The displaced families are presently housed at the Mahad Building (Islamic School) near Baumol Elementary School of the said Sitio.

### ACTIONS TAKEN:

- PNP personnel were immediately deployed to the area to neutralize the situation
- Injured victims were immediately brought to the hospital for medical treatment
- MDRRMO Lambayong is currently conducting DANA
- OCD XII is closely monitoring the said incident

## IV. BELATED REPORT RE DROWNING INCIDENT IN SOUTH COTABATO

### SITUATION OVERVIEW:

- On or about 6:00 PM of 15 January 2013, a drowning incident was reported at Sitio Pulo, Barangay Ned, Lake Sebu, South Cotabato because of heavy rains and caused El Gook Creek to increase its water volume.
- One (1) was reported dead and was identified as Marina Cadilleno (13 years old) upon riding a carabao and crossing the creek and was unfortunately swept away by the onrushing water of the creek.
- Her companion, Rex Cadilleno (15 years old), is still reported missing as of this time.

**ACTIONS TAKEN:**

- BDRRMC Ned coordinated with MDRRMO Lake Sebu
  - MDRRMC Lake Sebu conducted validation of the report
  - OCD XII coordinated with MDRRMO Lake Sebu regarding the incident
