1. PROGRESS REPORT RE INTERNALLY DISPLACED PERSONS DUE TO ARMED CONFLICT IN BUTUAN CITY

SITUATION OVERVIEW:

- On or about 3:00 PM, 6 March 2013, an armed encounter between the AFP Special Forces and the New People's Army occurred in Barangay Anticala, Butuan City, Agusan del Norte, forcing 150 families (750 persons) to flee their homes. A total of 80 families (400 persons) are currently being housed at the Tagkiling Tribal Elementary School in Brgy Anticala.
- As per report received from Capt. Emilio T. Bautista, commanding officer
 of the 9th Company under the 3rd Special Forces Battalion stationed at
 Brgy. Pianing, Butuan City, the ten (10) Special Forces personnel,
 previously reported missing, have returned safely to their camp on 7
 March 2013.

ACTIONS TAKEN:

- RDRRMC CARAGA is closely coordinating with the PNP and CDRRMC Butuan City to get more details on the encounter and distributed the following NFIs to the evacuees: 80 family hygiene kits, 96 sleeping mats, 96 mosquito nets, 200 blankets
- CDRRMC Butuan is currently monitoring the evacuation center and distributed food items to the evacuees
- 2. BELATED REPORT RE VEHICULAR ACCIDENT AT POBLACION, ALFONSO LISTA, IFUGAO PROVINCE

SITUATION OVERVIEW:

 On or about 5:45 AM, 8 March 2013, a vehicular accident occurred at National Highway Barangay Poblacion, Alfonso Lista, Ifugao Province involving a Potia Bus Liner with plate number PN BVT-509, driven by Edmund O. Chummac, 32 years old, married, and a resident of Caragasan, Alfonso Lista, Ifugao. The said bus accidentally bumped a house along a blind curve and fell into approximately 200 meter deep ravine. • The victims were brought to Potia District Hospital, Alfonso Lista, Ifugao.
