### 1. BELATED REPORT OF VEHICULAR ACCIDENT IN BRGY. BAYLAO, MAMBAJAO, CAMIGUIN

#### SITUATION OVERVIEW:

- On or about 10:30AM of 09 March 2013, a vehicular accident occurred in Brgy. Baylao, Mambajao, Camiguin
- The accident, involving a primemover Honda TMX155 bearing plate number KW7007, occurred along Bry. Baylao National Road in Brgy Poblacion going to Naasag
- The driver, identified as Ronald Rivera Arado, lose control of the vehicle when its left sidebar attachment accidentally broke and detached its position from the motorcycle which is carrying nine (9) passengers
- All passengers were injured and were brought to Camiguin General Hospital for medical treatment

#### ACTIONS TAKEN:

- Concerned people of Brgy. Baylao brought the victims to Camiguin General Hospital for medical treatment.
- **RDRRMC X** together with Mambajao Police conducted investigation on the incident

## 2. PROGRESS REPORT RE OIL SLICK/SLUDGE AT THE COASTAL WATERS OF LA UNION AND ILOCOS SUR

### SITUATION OVERVIEW:

- On or about 6:15 PM, 24 February 2013, CGDWLZN received a call from the PDRRMC La Union and reported that oil slicks were found at the coastal waters of Bangar, Luna, San Juan and San Fernando City, La Union
- Members of the Coast Guard, DENR-R1 and PDRRMC La Union conducted an ocular inspection and discovered scattered oil sludge/slick or tar balls in solid form at about 1-2 kilometers in length from Brgy. Paratong Norte to Brgy. Mindoro, both in Bangar, La Union
- The actual cause/source of the oil slick is still to be determined, however, the following speculations were made:
  1. Oil slick came from MV ARITA BAUXITE that capsized on 16 February 2013 in the waters of Bolinao, Pangasinan. The leaking oil may have travelled/washed away underwater and eventually emerged in La Union.
  2. Fisherfolks spotted a vessel that was docked in the waters of of Bangar a day before the oil slicks were discovered. The vessel may have sustained damage (ran aground) releasing oil or it may have intentionally dumped the oil.
- There were no report on fish kill, however, odor of oil slick is petroleum-based but disperses immediately.
- Oil spill monitoring and deployment of personnel for the conduct of clean- up operation, update as follows:

#### ACTIONS TAKEN:

- **PDRRMC** La Union, CG La Union with K9-NWLZ, CG Darigayos, CG Salomague and DENR I conducted an ocular inspection on 25 February 2013 to verify the oil spill, conducted clean-up operations and collected samples to determine the substance
- **CGDNWLZN**, CG San Fernando, CG Currimao, CG Candon and Marine Environment Protection Unit Northwestern Luzon (MEPU NWLZN) dispatched teams to different affected coastal city and municipalities of San Fernando, San Juan, Luna and Bangar, all in La Union to continue monitoring and clean-up operations in the reported oil slick/ sludge affected areas and to collect oil debris
- Provincial Government of La Union (PGLU) conducted an emergency meeting on 26 February 2013 re contingency planning and management of oil spill:
  - Manual cleaning (scooping) is preferred because oil dispersant chemicals may be harmful to human and marine life

- PGLU Engineering Office dispatched four (4) dump trucks for oil spill collection
  - PGLU Agricultural Office collected samples to determine substance and collected samples will be sent to Headquarters, Coast Guard District Northwestern Luzon (HCGDNWLZN) in Poro Point, San Fernando City, La Union.
  - OCDRC1 requested PNP and Reserve Units to augment in the clean-up drive
  - PGLU will purchase additional shovels, gloves and assorted containers for the operation
  - Provincial Government of La Union (PGLU) declared the entire province of La Union under a "State of Calamity" on 28 February 2013 with the resolution number 069-2013; conducted emergency meeting the same day with the following agreements/ discussions:
    - Collected oil/tar balls will be collected by PDRRMC for storage
    - Provincial Agriculture Office (BFAR) will conduct inspection as to the effect of the incident to the marine life
    - CG Ilocos Sur collected samples
    - PDRRMC Ilocos Sur conducted inspection in the affected shoreline
  - Affected LGUs in Ilocos Sur initiated clean-up drive
  - **DENR-I** notified the Municipal Mayors of Bangar, Bacnotan, Balaoan, Luna, San Juan and the City Mayor of San Fernando to issue an advisory to their constituents to refrain from eating, harvesting and marketing seafood from shoreline to 1km seaward.
  - **DRRMCs** Bangar, Luna, San Juan and San Fernando City coordinated with their respective barangays and local PNP for the immediate conduct of coastal clean-up and clearing operations
  - **PNP-PRO I** assisted in the clean-up operations
  - **OCDRC I**
    - requested the PNP-PRO I and Region I Reserve Units (ARESCOM) to report to their respective DRRM officers and extend support in the clean-up drive
    - Delivered 2,000 empty sacks and 10 pieces of shovel to La Union Provincial Engineering Office
    - Attended to media interviews and reminded the public to wear proper PPEs during clean-up
