#### **1. UPDATE ON THE AMBUSH INCIDENT IN NUNUNGAN, LANAOS DEL NORTE**

##### **SITUATION OVERVIEW:**

- On or about 5:00 PM, 25 April 2013, an undetermined number of armed men ambushed the convoy of the Mayor Abdul Malik Manamparan of Nunungan, Lanao del Norte
- The ambush incident resulted to the injury of Mayor Abdul Malik Manamparan who was rushed in Iligan Sanitarium and Hospital and now in stable condition, while his daughter Abnani Manamparan was confirmed as one of the fatalities
- A total of Twelve (12) persons died in the incident and they were identified as follows:

## **ACTIONS TAKEN:**

- PNP Nunungan and PA conducted hot pursuit operations against the attackers
  - 35<sup>th</sup> Infantry Battalion sent troops and ambulance to evacuate the victims
  - The Injured were brought to the Adventist Medical Center Iligan Sanitarium and Hospital for further medical treatment
  - **OCDRC 10 together with Lanao Del Norte PDRMO is still monitoring the situation especially for the possibility of threatened communities that may result to displacement**
