### **1. Heavy Rains in NCR**

#### **SITUATION OVERVIEW:**

- As of 4:30 PM, 27 April 2013, parts of Metro Manila is experiencing intermittent heavy rains with isolated thunderstorms
- East Avenue, Kamuning Road and Don Fabian, Commonwealth, all in Quezon City experienced flooding but the floodings have already subsided.

### **2. Vehicular Accident in Atimonan, Quezon**

#### **SITUATION OVERVIEW:**

- On or about 5:40 PM, 26 April 2013, a vehicular accident involving a Mitsubishi L300 van and an Isuzu trailer truck occurred at Diversion Road, Brgy. Catalina, Atimonan Quezon

- According to investigation, the said L300 van bound from Bicol Region to Metro Manila driven by Richard Clacio colided when the trailer truck driven by Roland Oguis y Macandog swerved to the opposite lane.
- The collision resulted to eight (8) injured persons. The victims of the said incident were rushed to Doña Martha Memorial Hospital and Emil Joanna General Hospital. The passengers and the driver of the van were later transferred to Lucena City Hospital.
