The Eligibility Checking as well as the Preliminary Examination of Bids shall follow a non-discretionary "pass/fail" criterion.

The Terms of Reference (TOR) in lieu of the Bidding Documents will be provided to all invited bidders/suppliers/contractors in accordance to GPPB Resolution No. 04-2012 dated 24 February 2012.

The bidder whose bid is found to be responsive to the agency's specification and an approved budget for the contract (ABC) shall be considered for award.

The proposals/quotations must be delivered on 31 May 2013 and the opening of the bids will be held thereafter at 3:00 P.M.. at the OCDA Conference Room, 2nd floor, OCD Administration Building Camp General Emilio Aguinaldo, Quezon City.

Bidding process shall govern by pertinent provisions of RA 9184 and its revised Implementing Rules and Regulations (IRR-A).

The OCD-DND reserves the right to accept or reject any or all proposals which is/are declared and/or annulled during the negotiation process or at any time prior to the award of contract, without incurring any liability to the Bidder/s.
