I. SITUATION OVERVIEW

A. CHRONOLOGY AND TYPHOON TRACK

02 July 2015

The Low Pressure Area (LPA) east of Luzon has developed into a Tropical Depression (TD) and was named "EGAY". At about 11:10 PM, TD "EGAY" has intensified into a Tropical Storm (TS) as it continues to move in a northwest direction.

03 July 2015

TS "EGAY" has intensified and slowed down and continues to move closer to Northern Luzon.

04 July 2015

At 11:00 AM, TS "EGAY" slightly accelerated at 13kph. As it continues to traverse towards Northern Luzon, "EGAY" has slowed down and further intensified into a Severe Tropical Storm (STS) with maximum sustained winds of 95 kph. STS "EGAY" has made landfall over Palanan, Isabela at about 11:00 PM.

05 July 2015

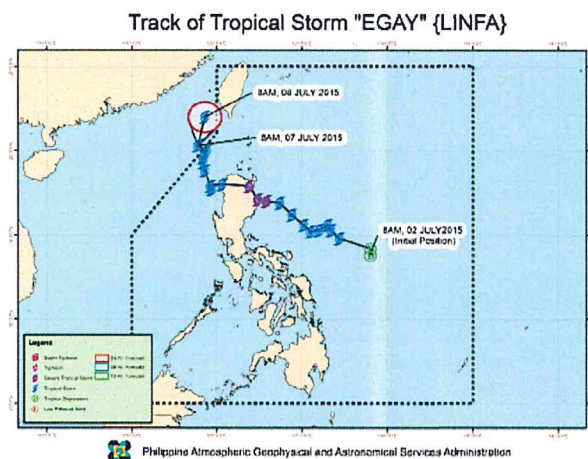
At 5:00 AM, STS "EGAY" has remained almost stationary since its landfall moving West Northwest at 7 kph. After STS "EGAY" traversed over Cagayan, it weakened slightly into a Tropical Storm and continues to move towards Luzon Sea.

06 July 2015

TS "EGAY" remained almost stationary over Luzon Sea. It slightly weakened and continues to move northward slowly.

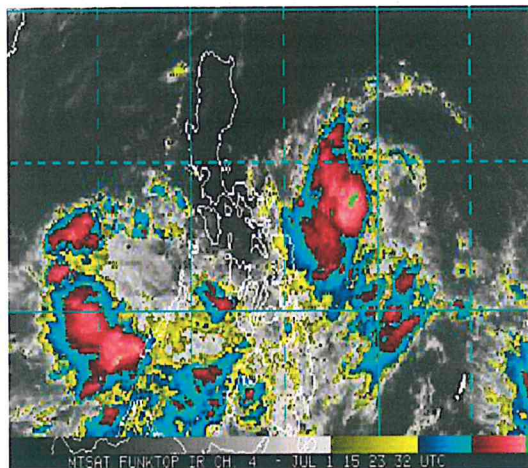
07 July 2015

"EGAY" slightly intensified before exiting the Philippine Area of Responsibility at around 9:00 AM.



B. TYPHOON ANALYSIS

EGAY (LINFA) is an area of convection embedded in the Intertropical Convergence Zone (ITCZ) inside the Philippine Area of Responsibility (PAR) East of Luzon. It developed into a Tropical Depression in the morning of 02 July 2015 and intensified into a storm at 8:00 PM same day as it moved northwest slowly.



In the evening of 04 July 2015, EGAY further intensified into a Severe Tropical Storm and made landfall over Palanan, Isabela then tracked across the provinces of Cagayan, Apayao, and Ilocos Norte. TS "EGAY" weakened into a Tropical Storm before exiting through the Northwestern border in the morning of 07 July 2015. PSWS #2 was raised over Kalinga, Apayao, Isabela, Quirino, Northern Aurora, Cagayan including Babuyan and Calayan Group of Islands. PSWS #1 was raised over Rest of Aurora, Nueva Ecija, Nueva Vizcaya, Ifugao, Benguet, Mt. Province, Ilocos Sur, Abra, and Ilocos Norte.

STS EGAY stayed inside PAR for five (5) days from 02-07 July 2015 and reached a maximum sustained winds of 95 kph near the center and gustiness of up to 120 kph on 04 July 2015, 4:00 PM. During its stay in the PAR, PSWS number 2 was the highest signal hoisted.

II. EFFECTS

A. INCIDENTS MONITORED (TAB A)

- a. A total of **four (4) landslide incidents** in Palawan, Benguet and Apayao, and **16 flooding incidents** in La Union, Palawan, Apayao, Mandaluyong City, Marikina City, and Pasay City were reported due to STS "EGAY".
- b. On 06 July 2015, a fishing vessel run aground in Currimao, Ilocos Norte. On board the vessel are one (1) Taiwanese and four (4) Chinese Nationals.

B. AFFECTED POPULATION (TAB B)

- a. A total of **13,280 families / 55,567 persons** were affected in Regions I, IV-B, and CAR.

C. CASUALTIES

- a. There were no reported casualties during the occurrence of STS Egay.

D. STATUS OF SEAPORTS

- a. The number of strandeers peaked at **1,147 passengers, 36 vessels, and 26 motorbancas** on 04 July 2015 which were reported in coast guard stations in Central Visayas, Northern and Eastern Luzon, Bicol, Palawan, and Southern Tagalog.

E. STATUS OF LIFELINES

WATER SUPPLY/TELECOMMUNICATION

- a. Municipality of Bacnotan reported interruption in water supply since 4:30 PM, 07 July 2015, while loss of landline and internet services were reported in the Municipalities of San Gabriel and Aringay, all in the Province of La Union.

ROADS and BRIDGES (TAB C)

- a. A total of eighteen (18) road sections and two (2) bridges in the Provinces of La Union, Ilocos Sur, Isabela, Apayao, and in the City of Pasay were rendered impassable due to incurred damages and flooding during the occurrence of STS Egay.

POWER SUPPLY (TAB D)

- a. Power outage / interruption was experienced in some areas in Provinces of La Union, Pangasinan, Ilocos Sur, Cagayan and Benguet. Power has been restored in some barangays in Cagayan and Benguet on 06 July 2015
- b. To date, power restoration is on going in some areas of La Union, Ilocos Sur, and Pangasinan.

F. DAMAGED HOUSES

- a. A total of **205 damaged houses** was reported in the Provinces of Ilocos Norte, Ilocos Sur, La Union, Palawan, Benguet, Abra and Kalinga. Of this number, **seven (7) were totally damaged** and **198 were partially damaged**:

DISASTER PREPAREDNESS
As of 09 July 2015, 8:00AM**

A. NATIONAL / NDRRMC**1. NDRRMC Operations Center**

- a. Alert status at the NDRRM Operations Center was raised to Blue Alert Status effective 03 July 2015, 6:00 PM and further heightened to Red Alert effective 8:00 PM, 04 July 2015 to continuously monitor and ensure dissemination of Severe Weather Bulletins, Weather Advisories, 24-hour Public Weather Forecasts, Gale Warnings, and General Flood Advisories to all RDRRMCs/OCDRCs through SMS, facsimile, and websites for further dissemination to their respective Local Disaster Risk Reduction and Management Councils (LDRRMCs) from the provincial down to the municipal levels.
- b. Directed Regions I, II, III, IV-B, VI, VII, and CAR to intensify their monitoring activities, preparedness measures, and precautionary initiatives to ensure safety of communities from the forecasted enhanced rains and threats brought about by the tropical cyclone.
- c. Pre-Disaster Risk Assessment (PDRA) Meeting was conducted on 03 July 2015, 12:00 NN, presided by the NDRRMC Executive Director and Office of Civil Defense (OCD) Administrator together with the PDRA Core Group at the NDRRM Operations Center, Camp General Aguinaldo, Quezon City.
- d. Follow-up PDRA Meeting was conducted on 04 July 2015, 4:00 PM, presided by Civil Defense Deputy Administrator Dir Romeo Fajardo together with PDRA Extended Core Group at the NDRRM Operations Center, Camp General Aguinaldo, Quezon City.
- e. Directed Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), Armed Forces of the Philippines (AFP), Philippine National Police (PNP), Bureau of Fire Protection (BFP), and Philippine Coast Guard (PCG) to render duty at the NDRRMC Operations Center effective 03 July 2015, 6:00 PM.

2. DOST-PAGASA

- a. Monitored the situation and disseminated Weather Bulletins, Gale Warnings, General Flood Advisories, and 24-hour Public Weather Forecast.

DOST II

- a. Monitored the installed Automatic Rain Gauges (ARGs), Water Level Monitoring Stations (WLMS) and Automatic Weather Stations (AWSs) in their AOR.

3. Department of Health (DOH)

- a. HEMB OPCEN was placed on Code White Alert effective 02 July 2015.
- b. Issued alert memorandum to all regional offices in preparation for Severe Tropical Storm "EGAY" and for prepositioning of teams and stockpiling of medicines.
- c. Reported the availability of logistics worth ₱45,172,585.03 at DOH Central Office.

DOH I

- a. On Code Red Alert to directly coordinate with RDRRMC I in monitoring incidents related to TS "EGAY".

- b. Activated four (4) provincial DOH offices Operations Center to directly coordinate with concerned local DRRMCs and local units for needed assistance.
- c. Alerted Cluster Heads of DOH RO I Public Health Team to be ready for deployment and provision of technical assistance and logistics.
- d. Prepositioned a total of ₱ 461,512.71 worth of assorted drugs and medicines to Provincial DOH offices (PDOHOs):
 - Ilocos Sur – ₱ 102,955.77
 - Ilocos Norte – ₱ 128,106.42
 - Pangasinan – ₱ 102,714.92
 - La Union – ₱ 127,735.60
- e. Reported the stockpile of assorted drugs and medicines in RESU-HEMS and Warehouse.
- f. Alerted the DOH retained hospitals: Region I Medical Center and Mariano Marcos Memorial Hospital and Medical Center for possible effects of STS “EGAY”.
- g. Conducted inventory and prepared drugs, medicines, and supplies amounting to ₱20,154,000.00.

DOH II

- a. Activated Operations Center and prepositioned drugs and medicines to five (5) Provincial DOH Offices (PDOHOs) amounting to ₱100,000.00 each.
- b. Placed Development Management Officers on standby.
- c. Notified retained hospitals in anticipation for any eventualities.
- d. Coordinated with RDRRMCs line agencies.
