I. Update Report re Fire Incident in Barangay Tandang Sora, Butuan City

A. Situation Overview:

- At 9:54 PM, 16 July 2015, a fire occurred at P2, Villanueva Extension, Barangay Tandang Sora, Butuan City which originated at the residence of Ms Jiji Aringca and also affected Barangay Limaha, Butuan City
- The incident was declared fire out at 11:54 PM on the same day
- More or less 100 structures consisting of residential houses, boarding houses, and sari-sari stores were affected by the incident with an estimated cost of damage worth ₱10,000,000.00
- A total of 203 families/ 1,218 individuals were affected by the fire. No casualties were reported.
- Cost of assistance amounted to PhP209,594.00 coming from DSWD (PhP84,854.00) and LGUs (PhP124,740.00)
- Two evacuation centers serving a total of 175 families / 1,050 persons were newly opened at T. Carlo Multi-Purpose Building with 55 families/ 330 persons and at Zacor Covered Court with 120 families/ 720 persons from Barangays Tandang Sora and Limaha in Butuan City.

B. Actions Taken:

- BFP Butuan City, Agusan Fil-Chinese Volunteer Fire Brigade Foundation, Inc., Gaisano Volunteer Fire Brigade, Water Tanker of Butuan City Government and other fire trucks from the neighbouring City/Municipality Fire Stations responded in the incident.
- RDRRMC CARAGA continuously monitors the situation and coordinates with the City DRRMC of Butuan, BFP Butuan Station and DSWD for updates.
- City DRRMC of Butuan distributed family packs containing 12 kilos of rice, 5 tin cans and noodles per pack amounting to PhP124,740.00

II. Fire Incident at Sitio Dupax, Brgy. Bantilan, Infanta, Quezon

A. Situation Overview:

- At 10:22 AM, 20 July 2015, a fire occurred within the residential area of Barangay Bantilan, Infanta, Quezon.
- The incident was declared fire out at 11:20 AM of same date.
- A total of sixteen (16) houses were gutted by the fire with three (3) persons reported injured and one (1) fatality, a disabled person.
- Still ongoing are the further identification of the victims, cause of fire, and the cost of damage.

B. Actions Taken:

1. BFP-Infanta, Real, DRRMO/Emergency Response Team responded in the incident.
2. OCD –RDRRMC IV-A coordinated with Infanta BFP.

III. Initial report re Food Poisoning in Sultan Kudarat, Maguindanao

A. Situation Overview:

- At 4:00 PM, 19 July 2015, a food poisoning incident caused by contaminated macaroni salad occurred in Barangay Simuay, Sultan Kudarat, Maguindanao.
- Thirty (30) people have experienced signs and symptoms of food poisoning including dizziness, stomach ache, nausea and vomiting.

B. Actions Taken:

- MDRRMC – Sultan Kudarat and Sultan Kudarat Response Team brought the victims to the Cotabato Sanitarium Hospital in Sultan Kudarat for immediate medical care.
 - OCD –RDRRMC ARMM coordinated with MDRRMC-Sultan Kudarat for updates.
