### **A. Initial Report re Flashflood in Sultan Kudarat, Maguindanao (Region XII)**

#### **Situation Overview**

- At 2:00 PM, 04 August 2015, Barangays Mulaog and Banubo of Sultan Kudarat experienced flashfloods due to intermittent light to heavy rains for the past few days caused by ITCZ affecting Mindanao.
- To date, there are no reported casualties and population displacement in that area.
- The National Highway (Cotabato-Davao route) traversing the municipality are still passable to all types of vehicle.

#### **Actions Taken:**

- Ongoing assessment by the MDRRMC concerned particularly on the number and status of flashflood-affected population and other possible effects in Sultan Kudarat.
- Close monitoring and coordination is being continuously pursued by OCD/RDRRMC-ARMM/HEART with concerned MDRRMC and PDRRMO-Maguindanao on other possible flooding incidents in the province due to the prevailing weather condition.

### **B. Final Report re Flashflood at Malaybalay City, Bukidnon (Region X)**

#### **Situation Overview**

- At 10:00 PM, 03 August 2015, a flashflood incident transpired at Purok 4 Lalawan, Brgy. Linabo, Malaybalay City, Bukidnon due to heavy rains brought by the Inter-Tropical Convergence Zone (ITCZ).
- As a result thereof, a total of 12 families/52 persons evacuated at Brgy. Linabo covered court.
- No damages reported so far.**

#### **Actions Taken:**

- The CDRRMO personnel composed of two (2) teams immediately proceeded to the area and conducted immediate evacuation.
- The affected families returned to their respective homes today, 04 August 2015.**
- RDANA is being conducted by the City Admin Office, CDRRMO, and City Agriculture Office.**



### C. Progress Report re Sinking of MV “LCT Emilia 2” in the Municipality of Tabina, Zamboanga del Sur (Region IX)

#### Situation Overview:

- On 28 July 2015, a Motor Vessel named “LCT Emilia 2” coming from Pollok, Cotabato and bound for Lamitan City, Basilan Province encountered engine trouble.
- On or about 10:43 AM of 01 August 2015, CGS-Olutanga established contact with the vessel and were able to fix the engine and continue steaming with one (1) engine en route for Basilan Province.
- At about 2:00 PM of 01 August 2015, the ship arrived at the coastal area of Brgy. Baganian, Tabina, Zamboanga del Sur.
- At around 4:00 PM of 02 August 2015, the MV “LCT Emilia 2”, with 15 crew members aboard, started tilting when it was hit by big waves while at the vicinity 1.5 nautical miles, southeast off the seawaters of Baganian Peninsula, Tabina, Zamboanga del Sur. It forced the vessel skipper to declare the abandonment of their ship.

#### Effects

- Fourteen (14) crew members of the ill-fated motor vessel were rescued while one (1) was reported dead.
- The lifeless body of Chief Mate Nashruddin Ayunan was retrieved inside the cabin of the sunken vessel at about 11:08 AM, 03 August 2015.
- The 14 crew members including the skipper rescued were identified as:

#### Actions Taken:

- OCD IX verified the information with the Coast Guard Pagadian Station re the capsized vessel
- Tabina Mayor Dayondon immediately activated and deployed the SAR Team. He also instructed PSI Raymundo Mangual, OIC-Tabina MPS to send PNP personnel to the incident site.
- Upon receipt of the verified report, Mayor Dayondon along with MSWD Officer, MAO and President of Municipals Women’s Federation went to the area to conduct initial assessment and assist the survivors.
- Tabina Search and Rescue (SAR) Team rescued the 14 crew members.



- e. At about 5:10 AM of 03 August 2015, eight (8) personnel from CGS-Pagadian together with OCD IX personnel onboard AB-270 and RB-33 proceeded to the incident area to conduct maritime search, rescue and retrieval operations.
- f. At around 6:00 AM, 03 August 2015, certified scuba divers of Tabina SAR Team led by Mayor Dayondon conducted SRR operations to locate the missing crewman.
- g. At around 6:30 AM, 03 August 2015, elements and personnel of CGS-Pagadian and OCD IX arrived in Brgy. Baganian to conduct further assessment and assisted in SRR operations.
- h. SAR Team from Coast Guard Pagadian and OCD personnel assisted in the SAR operations.
- i. Tabina-DRRMC brought the survivors to the house of the Mayor for assistance.
- j. OCD IX coordinated with ZDS-PDRRM, Tabina-MDRRM and Coast Guard for information and updates on the incident.
- k. Stress debriefing was conducted to the 14 survivors by Tabina RHU personnel.
- l. Tabina-MDRRMC provided meals and dry clothing to the survivors.
- m. Tabina-Women Federation contacted the immediate families of the crew members.
- n. OCD IX is continuously monitoring and coordinating with Tabina-MDRRM Office and Coast Guard Station Pagadian City for additional information of the incident.

#### **D. Initial Report re Flashflood in Pikit, Cotabato Province (Region XII)**

##### **Situation Overview:**

- a. Continuous heavy rains transpired in Pikit, Cotabato Province which caused floods in the sixteen barangays affecting 7,386 families.

##### **Actions Taken:**

- a. MDDRMC distributed family food packs to the affected families
- b. MDDRMC in coordination with the respective BDRRMCs continuously conducting assessment and validation on the affected area.
- c. OCD XII personnel dispatched to the affected area to assist and monitor the situation.

#### **E. Initial Report re Pre-emptive Evacuation at San Jose, Malaybalay City, Bukidnon (Region X)**

##### **Situation Overview:**

- a. Pre-emptive evacuation was carried out on Sitio Panamukan, San Jose, Malaybalay City, Bukidnon due to heavy rains experienced caused by ITCZ. A total of 16 families/100 persons were affected.

##### **Actions Taken:**

- a. The CDRRMO Malaybalay assisted the affected families in the pre-emptive evacuation and coordinated with the CSWD for the distribution of food packs.
