1. Fire Incident Involving M/V Wonderful Stars in Ormoc City (Region VIII)

A. Situation Overview

- On 15 August 2015, M/V Wonderful Stars – Roble Shipping reportedly arrived in Ormoc City from Pier 2, Cebu City at 3:15 AM with total of 544 passengers and fifty-nine (59) crew members aboard
- According to initial investigation, the fire started from one of the cabins at 4:20 AM while the passengers were disembarking
- At 1:00 PM, the fire was declared fire out

B. Effects

- Two (2) crew members were reported injured and were brought to Ospal Hospital:
 - Jake Rondell Guinocor
 - Daryll Lee Bentoy

C. Actions Taken

- At 4:33 PM, 15 August 2015, Emergency Coordination Meeting was facilitated by OCD VIII attended by MARINA, PCG, BFP, ROBLE Shipping, PPA, DOH-HEMS, PRC, Ormoc CDRMO and PNP Ormoc to discuss the ongoing operations and logistical concerns
- **OCD VIII** coordinated with BFP Regional Officer re availability of CO₂ to be used for fire suppression and attended the planning meeting for fire suppression together with BFP, Ormoc City – DRRMO and ROBLE Shipping
- **OCD VIII** coordinated with DPWH District Engineering Office for the availability of backhoe and pay loader; continuously monitors the incident for further updates

- **Ormoc CDRRMO** deployed ORMOC RESCUE Team
- **Philippine Coast Guard-Ormoc City**
 - Responded to the incident with BFP and Ormoc CDRRMC
 - Deployed aluminum boats and coordinated with Petron re oil spill boon
 - Established Incident Command Post with Ormoc CDRRMO, CHO-Ormoc City, and BFP
- **Bureau of Fire Protection** coordinated with nearby fire stations for augmentation
- **PRC Ormoc Chapter** established First Aid and Welfare Station adjacent to the ICP
- **PNP Ormoc City** cordoned the area for the on-going operations and provided security
- **MARINA** is continuously monitoring the situation and conducting initial investigation
- **Energy Development Corporation** assisted operating agencies in logistical requirements
- **ROBLE Shipping** established help desk at ROBLE Shipping Office for the concerns of the passengers and assured full cooperation and officers and crew on the investigation

2. Progress Report re Explosion in Patikul, Sulu (ARMM)

A. Situation Overview

- At 2:00 PM, 14 August 2015, an improvised explosive device was detonated at Patikul National High School in Patikul, Sulu

B. Effects

- A total of four (4) persons were injured and were rushed to Sulu Provincial Hospital for medical treatment. **Injured persons are as follows:**
 - **Dajdi A. Nani – 61 y/o, male**
 - **Nurhaida Ladja – 18 y/o, female**
 - **Lea Banagudos – 17 y/o, female**
 - **Wilmuna Biting – 17 y/o, female**

A. Actions Taken

- OCD ARMM coordinated with the MDRRMO Patikul relative to the incident
 - PNP Patikul secured and conducted investigation in the area
