## 1. Explosion Incident in Sitio Taguisan, Bagong Nayon, Antipolo City.

## A. Situational Background

- At around 10:35 AM, 23 August 2015, a hand grenade exploded in Sitio Taguisan, Bagong Nayon, Antipolo City.
- Two (2) persons are reported dead while four (4) other persons were injured as a result of the explosion. The victims were then rushed to the hospital.
- Recovered in the area are two pieces of hand grenades, assorted live ammunitions, drug paraphernalia and sachet with traces of suspected shabu.

### B. Effects

#### C. Actions Taken

- Antipolo CDRRMO, BFP, and PNP responded to the incident.
- OCD-IVA coordinated with Antipolo CDRRMO for information and updates on the incident.

## 2. Fire Incident at Brgy. Baclaran, Parañaque City

#### A. Situational Background

 At around 10:37 PM, 23 August 2015, a fire incident involving five (5) residential houses occurred along Lapu-Lapu Street, Brgy. Baclaran, Parañaque City.

- The fire reached 1<sup>st</sup> Alarm at around 10:49 PM, 23 August 2015 and declared fire out at about 12:29 AM on the following day.
- The cause of fire is still under investigation.

#### B. Effects;

- Fifteen (15) families were affected.
- · No report of casualty or injured.
- Cost damage is estimated at PhP50,000.00

#### C. Actions Taken

- BFP Parañague City and fire volunteers responded to the incident.
- Responding agencies were 131 Alpha, 132, 128 and Parañaque Tanker.
- OCD-NCR coordinated with BFP Paranaque City and BFP NCR.

## 3. Fire Incident at Dangay Street, Barangay Veterans, Quezon City

## A. Situational Background

- At around 6:16 PM, 23 August 2015, a fire incident involving residential house occurred at Dangay Street, Barangay Veterans, Quezon City
- The fire reached 1<sup>st</sup> Alarm at around 6:16 PM, 23 August 2015 and declared fire out at about 8:13 PM.
- The cause of fire and cost of damages is still under investigation.

#### B. Actions Taken

- BFP Quezon City and fire volunteers responded to the incident.
- OCD-NCR coordinated with BFP Paranague City and BFP-NCR.
