1. Initial Report re Vehicular Incident in Zamboanga City

### A. Situation Overview:

- At 4:25 am, 06 September 2015, a vehicular incident transpired at Mercedez Highway junction Pasobolong, Zamboanga City involving a Rural Transit Bus with plate number JVH-919 and driven by certain Regemio Bambao. The bus is said to be heading to Zamboanga City proper from Pagadian City.
- Investigation disclosed that the bus ran off the highway and bumped a motorcycle owned by a certain Amelia Buco who at that time was beside her parked vehicle. The bus then smashed into two (2) houses both owned by Colonia family until it fell into a ravine and finally rested in an inclined left position.

## B. Effects

 A total of two (2) individuals were reported dead and eleven (11) were injured, namely:
