### **1. Belated Report re Vehicular Incident in Lingayen, Pangasinan**

#### **A. Situation Overview**

- At about 6:10 AM 17 September 2015, a vehicular incident transpired along Brgy. Domalandan Center, Lingayen, Pangasinan involving an Isuzu jeepney.
- Initial investigation disclosed that the said jeepney tried to overtake a motorcycle and suddenly lost control hitting the concrete house of Carmelita Quinto.
