I. SITUATION OVERVIEW:

TYPHOON "JENNY" has slightly intensified as it moves in a Northwest direction.

Location of Center: (as of 10:00 AM)	860 km East of Basco, Batanes
Coordinates:	21.2°N, 130.1°E
Strength:	Maximum sustained winds of 140 kph near the center and gustiness of up to 170 kph .
Movement:	Forecast to move Northwest at 13 kph.
Forecast Positions/Outlook:	 24 hour (Tomorrow morning): 645 km East of Northeast of Itbayat, Batanes 48 hour (Monday morning): 505 km Northeast of Itbayat, Batanes. 72 hour (Tuesday evening): 515 km North Northeast of Itbayat, Batanes, outside the PAR. 96 hour (Wednesday evening): (outside PAR) 790 km North Northwest of Itbayat, Batanes. 120 hour (Thursdayday evening): (outside PAR) (outside PAR) 1080 km Northwest of Itbayat, Batanes.

- Estimated rainfall amount is from moderate to heavy within the 600 km diameter of the Typhoon.
- Fisher folks are advised not to venture out over the eastern seaboards of Southern Luzon, of Visayas and of Mindanao.
- The southwest monsoon enhanced by TY "JENNY" is expected to bring moderate to occasionally heavy rains over Palawan, Western Visayas and Zamboanga Peninsula.
- The public and the disaster risk reduction and management council concerned are advised to take appropriate actions and watch for the next update which will be incorporated in the 24-Hour Public Weather Forecast to be issued at 5 PM today and for the next Severe Weather Bulletin to be issued at 11 PM today.

II. ACTION/S TAKEN

- NDRRMC Operations Center disseminated Severe Weather Bulletin No. 07 re Typhoon "JENNY" to all OCD Regional Centers through SMS and facsimile and uploaded on the NDRRMC website for further dissemination to their respective local disaster risk reduction and management councils (LDRRMCs) from the provincial down to the municipal levels
- Directed RDRRMCs concerned through the OCD Regional Centers to undertake precautionary measures in their areas of responsibility (AOR) and subsequently advised local DRRMCs to initiate pre-emptive evacuation of families in low-lying and mountainous areas if situation warrants
