1. Belated Report on the Pre-Emptive Evacuation in Davao del Norte (Region XI)

A. Situation Overview:

1. Per belated report gathered by OCD Region XI, the Philippine Institute of Volcanology and Seismology (PHIVOLCS) Central Office issued Deployment of Early Warning Systems – Landslide (DEWS-L) Program Landslide Alert Level Information 2 on 15 September 2015, through the MDRRMO because of imminent landslide in Sitios Lower and Upper Mesolong in Barangay Sto. Niño, Talaingod, Davao del Norte.
2. The recommended response for Alert Level 2 is to evacuate all potentially households within the given area. A total of six (6) directly affected households were pre-emptively evacuated.

B. Effects:

1. Out of the 188 families evacuated, sixty-eight (68) families from Sitio Lower Mesolong are still staying in the Municipal Gym.
2. The 120 families from Sitio Upper Mesolong were allowed to return home after Alert Level 0 was raised on September 21, 2015.

C. Actions Taken:

1. OCD XI is in close monitoring for any update of the situation.
2. MDRRMC Talaingod in coordination with PDRRMC Davao del Norte distributed food packs and potable water to all affected families in the area.
3. MDRRMC Talaingod conducted debriefing activity through a Film Showing to relieve the stress from the affected families.

2. Vehicular Accident in Lamut, Ifugao (CAR)

A. Situation Overview:

1. On or about 7:20 PM 23 September 2015 7:20 PM, a white Toyota Hi-Lux with plate number UGQ-257 owned by Oceana Gold Corp. lost control and hit the side of the road, causing the vehicle to turn upside down in Hapid Road, Brgy. Sanafe, Lamut, Ifugao.

B. Effects:

1. A total of two (2) persons were reported dead and four (4) persons were injured:

C. Actions Taken:

1. PNP Lamut conducted investigation and secured the place of incident.
2. MHO Lamut, MDRMO Lamut/LERT and Sanafe BDRRMC conducted rescue operations to the incident.
3. Panopdopan District Hospital and Dela Cruz Medical Clinic collated and validated report received at OCD-CAR Operations Center.
4. PDRMO coordinated with Provincial Health Office and OCD-CAR.

3. Progress Report on the Fire Incident at AFP Medical Center in Quezon City (NCR)**A. Situation Overview:**

- On or about 7:00 PM 23 September 2015, a fire occurred at AFP Medical Center in V. Luna, Brgy. Piñahan, Quezon City.
- Involved was the 3-storey Officer Nurses Quarters.
- The said fire was raised from 1st to 3rd alarm and was **declared fire-out at around 1955H** by the Quezon City BFP.

B. Action Taken:

- Quezon City BFP **and DRRM Rescue** responded to the incident.
