I. SITUATION OVERVIEW

A. Chronology and Tropical Storm Track

30 September 2015

 Weather Bulletin was issued for the Low Pressure Area (LPA) east of Visayas which was forecasted to bring light to moderate rains and thunderstorms over the regions of Eastern Visayas, CARAGA, and Davao.

01 October 2015

 The LPA developed into a Tropical Depression (TD) at 10:00 AM and was named "KABAYAN" with international name MUJIGAE. "KABAYAN" intensified into a Tropical Storm (TS) at 10:00 PM and threatened Central Luzon as it moved in a northwest direction.

 Public Storm Warning Signal (PSWS) No. 1 was raised in the Provinces of Catanduanes, Camarines Sur, Camarines Norte, Aurora, and Northern Quezon including Polillo Island. It made landfall over Aurora and tracked across Central Luzon.

02 October 2015

- TS "KABAYAN" made a landfall over Baler-San Luis, Aurora at 4:00 AM and traversed Central Luzon. "KABAYAN" exited landmass at 10:00 AM and moved towards the West Philippine Sea
- PSWS No. 2 was issued to the Provinces of La Union and Pangasinan while PSWS No. 1 was raised in the Provinces of Benguet, Tarlac, Ilocos Sur, and Zambales.

03 October 2015

TS "KABAYAN" left the Philippine land mass through Pangasinan.

B. Tropical Storm Analysis

Tropical Storm "KABAYAN" is the 11th tropical cyclone which entered the Philippine Area of Responsibility (PAR) on the year 2015. "KABAYAN" developed into a Tropical Depression on 01 October 2015 and intensified into a Tropical Storm on the same day.

"KABAYAN" made a landfall over Aurora on 01 October 2015 and raised PSWS No. 1 in the Provinces of Catanduanes, Camarines Sur, Camarines Norte, Aurora, and Northern Quezon including Polillo Island.

On 02 October 2015, PSWS No. 2 was issued to the Provinces of La Union and Pangasinan while PSWS No. 1 was raised in the Provinces of Benguet, Tarlac, Ilocos Sur, and Zambales.

PSWS No. 2 was the highest storm warning signal hoisted, with highest maximum sustained winds recorded at 95 kph near the center, gustiness of up to 120 kph, and highest 24-hour rainfall amount of 134.0 mm which was recorded in Iba, Zambales. At 5:00 PM, 02 October 2015, all PSWS were lifted.

"KABAYAN" exited the western border of the PAR as a Severe Tropical Storm or STS.

II. EFFECTS

A. Incidents Monitored (TAB A)

A total of **43 incidents were monitored** – two (2) landslides, six (6) flooding, two (2) vehicular accidents, and thirty-three (33) maritime incidents.

B. Affected Population

1. A total of <u>12,281 families / 59,568 persons</u> were affected in Regions I and III. All affected families in the evacuation centers have returned to their respective homes:

III. DISASTER PREPAREDNESS (TAB D)

Alert status at the NDRRM Operations Center was raised to Blue Alert Status on Ottober 2015 to continuously monitor and ensure dissemination of Weather Advisories, 24-hour Public Weather Forecasts, Gale Warnings, and General Flood Advisories to all RDRRMC / OCDROs through SMS, facsimile, and websites for further dissemination to their respective Local Disaster Risk Reduction and Management Councils (LDRRMCs) from the provincial down to the municipal levels.

IV. DISASTER RESPONSE

- OCD I conducted an Emergency Meeting regarding establishment of Incident Command Post (ICP) for TS "KABAYAN" on 06 October 2015 at OCDRC I Conference Room and was attended by the Regional and Provincial DRRMC member-agencies.
- 2. ICP was established at the OCD Regional Office for consistency of reports and coordination of operations.

A. Food and Non-Food Items (F/NFIs)

- **1.** DOH I allocated drugs and medicines and other supplies in four (4) provincial DOH offices.
- 2. PDRRMC Nueva Ecija and PSWDO Nueva Ecija distributed 6,329 family food packs to all affected families in Bongabon, Cabanatuan City and Palayan City.
- 3. PDRRMC Nueva Ecija provided a total of ₱359,850.00 worth of assistance to the affected families in the following Municipalities/City: Palayan City ₱14,350.00; Laur ₱160,000.00; and Bongabon- ₱185,500.00.
- **4.** LGU Baler provided ₱46,360.00 worth of assistance to the affected families.

B. Protection, Camp Coordination and Management (PCCM)

1. DSWD FO-III continuously monitored the evacuation centers.

C. Search, Rescue, and Retrieval (SRR)

NATIONAL

- **1.** 7ID, PA conducted rescue operations for those affected families in the Province of Nueva Ecija.
- 2. CSAFP, in coordination with WESCOM and NOLCOM, mobilized PS-70 (Patrol Corvette) boat docked in Puerto Princesa City (PPC), Palawan and PNI-314 (Islander) aircraft based in Antonio Bautista Airbase, PPC, to help locate the missing vessels and fishermen in Pangasinan.
- 3. The Philippine Navy (PN) dispatched PN Islander (PNI) 314 and PN Islander 311 for the conduct of aerial surveillance in the vicinity of La Union, Zambales, and Ilocos Norte and dispatched PS-36 PN ship from Bataan to Cape of Bolinao for the conduct of SAR operation on 06 October 2015.
- **4.** The Philippine Navy deployed PS-36 PN ship for the conduct of SAR operations up to 80 nautical miles west off Cape Bolinao in search for the missing fishermen on 07-08 October 2015.
- **5.** The Philippine Navy deployed PG 369 to conduct SAR operations at 20 nautical miles from the shoreline of Subic to Sual, Pangasinan
- 6. The Philippine Navy Islander (PNI) 311 conducted SAR operations at 200 nautical miles northwest of San Fernando City, La Union on 10 October 2015 and sighted seven (7) persons aboard a make shift bamboo platform. PNI 311 instantly broadcasted NOTAM through Channel 16 of the Marine Band Radio. M/V Kavala Seas, a bulk carrier heading towards Singapore, was in the vicinity and immediately responded to the call. The PN and PDRRMC La Union sent-out a rubber boat and one (1) patrol boat, respectively, to fetch all seven (7) victims from M/V Kavala Seas anchored in Poro Point. The victims were brought to llocos Training and Regional Medical Center (ITRMC) for medical treatment.
- **7.** PN vessel PF15 refueled at Pier 13 and conducted SAR operations for the remaining missing fishermen.
- **8.** Coast Guard District Northwestern Luzon (CGDNWLZN) conducted SAR operations for the missing fishermen from Dasol, Agno, Bolinao, and Infanta, Pangasinan in coordination with MDRRMOs.
- 9. CGDNWLZN dispatched facsimile message regarding the following:
 - a. Distress alert in which "NYK Joanna" sighted seven (7) persons waving hand signals for rescue near Salomague Island.
 - b. An unnamed motorbanca requesting assistance near Bolinao, Island.
 - c. A distress alert near Port of Esteban, Ilocos Sur.

- **10.** Dispatched Notice To All Mariners (NOTAM), regarding warnings and distress alerts that can augment SAR operations.
- **11.**Coast Guard Action Center (CGAC) immediately coordinated and informed SARV-001, TB-271, MCS-3001 and MCS-3007 to be on alert for possible dispatch regarding the missing Motor Yacht Europa. On 08 October 2015, MCS-3002 of PCG made re-watering provision enroute to SAR area. CGAC also coordinated and requested augmentation from USCG.
- 12. CGAC was informed through email by Hong Kong Maritime Rescue Coordination Centre (HKMRCC) that three (3) vessels namely: M/V Far Eastern, M/V Tiansheng 26, M/V Uni Prudent and one (1) fishing vessel conducted SAR operation for the missing Motor Yacht Europa. On 07 October 2015, the three (3) private vessels terminated their SAR operations.
- **13.** The HKMRCC also conducted aerial search on 07 October 2015 and informed that the Emergency Position-Indicating Radio Beacon (EPIRB) of the said missing yacht had stopped transmitting signals, which left the supposed SAR with no reference to follow their search.
- 14. CGAC coordinated and informed that SARV-001 conducted SAR operations for the missing yacht and fishermen. However, on 10 October 2015, SAR operations conducted at the vicinity off San Fernando City, La Union, 223 nautical miles west of Cape Bojeador, Ilocos Norte yielded negative result.
- **15.** DILG closely coordinated with OCD and DOH for the needed cadaver bags, surgical gloves, and masks provided to the Philippine Navy aboard BRP Apolinario Mabini for their conduct of SAR operations. Further, DILG coordinated with PNP for the handling of the found cadaver.
- **16.** On 10 October 2015, DILG immediately coordinated with DSWD Regional Office for the financial and food assistance of the seven (7) rescued fishermen of F/B Double J fishing vessel.

LOCAL (R/P/C/MDRRMCs)

- 1. OCD I, PDRRMC La Union, and PDRRMC Pangasinan, deployed Water Search and Rescue (WASAR) for augmentation of SAR operations to those reported missing fishermen in the Municipalities of Infanta, Bolinao, Agno, and Dasol in Pangasinan.
- 2. OCD I constantly coordinated with concerned agencies regarding the needed assets/resources for the turn-over of the cadaver from PN to DILG and PNP at Poro Point, San Fernando City, La Union on 08 October 2015 at 7:30 AM.
- 3. PDRRMC Aurora, MDRRMC Baler, Philippine Army, and Baler Fisher Folk Association conducted SAR operation regarding the 14 missing fishermen from Baler, Aurora. MDRRMC Baler deployed 12 fishing boats and two (2) speed boats for the conduct of SAR operation.
- **4.** PDRRMC La Union, in coordination with PN Naval Task Force (NTF) 40, sent two (2) ambulances to bring the victims to Ilocos Training and Regional Medical Center (ITRMC).
- 5. PDRRMC Nueva Ecija conducted rescue operations in Palayan City on 02 October 2015. CDRRMO Palayan and PDRRMO Rescue Teams rescued 12 persons trapped by floodwaters at Bangkerohan, Palayan City on 02 October 2015. LDRRMO Bongabon together with Philippine Army conducted rescue operation on families affected by 2-3 feet of floodwaters in Barangay Lusok, Bongabon, Nueva Ecija.

- **6.** PDRRMC Tarlac deployed DART/EMS and Flood Swift Water Team with 13 personnel, one (1) unit 6x6 SKE rescue truck, two (2) units rescue boat with trailer, one (1) unit of Toyota Humvee, and other flood swift water equipment to augment in the rescue and evacuation in Cabanatuan City, Nueva Ecija.
- 7. The DILG Provincial Director of Pangasinan provided financial assistance to the seven (7) rescued crew of F/B Double J.
- **8.** PIA I invited the OCD I Director to provide updates about TS "KABAYAN" and to impart what had transpired during the Council meeting.

D. Logistics

- 1. DPWH District I Engineering conducted clearing operation on the landslide area in Barangay Ligaya, Gabaldon, Nueva Ecija.
- 2. DPWH IV-B and MDRRMC Buenavista, Marinduque conducted clearing operations on the landslide area in Barangay Libis and Yook, Buenavista, Marinduque.
- **3.** National Grid Corporation of the Philippines (NGCP) mobilized line crews to conduct aerial and ground patrols to inspect and assess the impact of TS "KABAYAN" to its operations and facilities.
- **4.** SOLCOM assisted in clearing of fallen trees along provincial and municipal roads in Aurora, Nueva Ecija and Nueva Vizcaya.
- 5. PDRRMC Tarlac deployed PDRRMC DART/EMS and Flood Swift Water Team with personnel and equipment/assets to augment in the Rescue and Evacuation in Cabanatuan City, Nueva Ecija.
- **6.** MDRRMCs Dipaculao, Maria Aurora, and Baler conducted clearing operations to major roads due to fallen trees and other debris.

E. Management of the Dead and Missing (MDM)

1. The MDM Cluster Core Group conducted an emergency meeting regarding the missing fishermen on 06 October 2015, 11:00 AM, at the NDRRMOC, Camp Gen. Emilio Aguinaldo, Quezon City.

Effects re TS "KABAYAN" DISASTER PREPAREDNESS

A. National / NDRRMC

1. NDRRM Operations Center (NDRRMOC)

- a.
