### **1. Progress Report re Fire Incident at Brgy. Tumaga, Zamboanga City (Region IX)**

#### **A. Situation Overview:**

1. Around 12:00 PM, 05 October 2015, a fire occurred at Sitio Claridad, Morga, Bagong Silang and Siera Madre, Brgy. Tumaga, Zamboanga City, totally burning more or less **280** houses made of **semi-concrete** and light materials.
2. **Initial investigation disclosed that the fire started at the house of certain Girlie Brosas, 25 years old, and a resident of Sitio Bagong Silang, Tumaga, Zamboanga City.**
3. As of reporting time, the cause of fire is still under investigation.

#### **B. Effects:**

1. About **285** families were affected.
2. One (1) person was reported dead, **namely Mr. Solomon Agoso, 75 years old. Meanwhile, the previously reported missing person was found to be reunited with his/her family.**
3. Estimated cost of damage is five million pesos (P5,000,000.00).

#### **C. Actions Taken:**

1. Sta. Maria Fire Bureau, Sta. Maria Police Station, Guiwan Fire Station, Zamboanga City Central Fire Station, Boalan Fire Station, **Tetuan Fire Station, Sta. Catalina Fire Station, Ayala Fire Station, Philippine Airforce Fire Truck, and Zamboanga City Water District Fire Ambulance including two water tankers** responded to the fire incident.
2. OCDRC IX dispatched Civil Defense Action Group (CDAG) operatives to conduct on sight monitoring and continuously monitoring of its AOR for any disaster-related incident.

### **2. Initial Report re Landslide Incident at Tambulig, Zamboanga del Sur (Region IX)**

#### **A. Situation Overview:**

1. Around 7:00 PM, 05 October 2015, a landslide incident occurred in Purok 6, Barangay Calolot, Tambulig, Zamboanga del Sur due to localized thunderstorm that brought heavy rains in that area.



**B. Effect:**

1. As a result, the provincial road is not passable to all types of vehicles due to landslide. In addition, the box culvert and road drainage system along the provincial road of Barangays Upper Loding and Tuluan were also damaged.

**C. Actions Taken:**

1. Municipal Disaster Risk Reduction Management Office (MDDRMO) headed by their Chairman convened the council to initiate the clearing operation to be conducted by the engineering team.
2. MDRRMO with Municipal Engineer immediately conducted actual assessment of the affected barangays.
3. OCDRC IX Operations Center is continuously monitoring its AOR for any disaster-related incident.

**3. Initial Report re Drowning Incident in Pangil, Laguna (Region IV-A)****A. Situation Overview:**

1. Around 10:30 AM, 04 October 2015, a drowning incident happened at the Buntot Palos Falls, Brgy. Balian in Pangil, Laguna.
2. The victim was identified as Mr. Edward Dizon, 23 y/o of Brgy. Banaybanay, Cabuyao City. He went to the said falls for trekking and swimming. Shortly, his friends noticed that he was missing. They immediately reported the incident to the Barangay officials in that area.
3. The body of the victim was found floating in the site of the incident on 06 October 2015. It was retrieved by responders from CGS Laguna, Pangil MDRRMO and Barangay DRRMC.

**B. Actions Taken:**

1. Pangil MDRRMO, Pangil MPS and Barangay BDRRMC proceeded to the area for verification and subsequent SAR operations.
  2. The Laguna Emergency Response Team augmented the ongoing SAR operations and coordinated with CGS Laguna for the availability of divers.
  3. OCD/DRRMC IV-A continuously coordinated with PDRRMO Laguna and MDRRMC Pangil regarding this incident.
