I. Vehicular Accident in Purok Herbal, Brgy. Sicade, Kumalarang, Zamboanga del Sur (Region IX)

#### A. Situation Overview:

- On or about 19000H 20 October 2015, a vehicular accident transpired along the National Highway in Purok Herbal, Brgy. Sicade, Kumalarang, Zamboanga del Sur.
- A bus liner of Rural Transit Mindanao Incorporated (RTMI) was traversing the said highway from Ipil, Zamboanga Sibugay bound to Pagadian City, Zamboanga del Sur when the driver allegedly applied the brakes due to a slight hump on the road. The driver was not able to properly maneuver the steering wheel due to slippery road caused by the rainy weather. The bus then went off course and fell on the field on the side of the road.
- The driver was identified as Mr. Joseph Caburnay y Fajardo, 31 years old, married and a resident of Brgy. Gandiangan, Imelda, Zamboanga Sibugay.
- Twelve (12) of the thirteen (13) injured victims was transported to the Zamboanga Medical Center for medical treatment while the remaining one (1) injured victims just went home immediately. As per latest report from OCD IX (23 October, 2015), the twelve (12) victims that were hospitalized were already discharged and sent to their respective homes.

#### B. Effects:

#### C. Actions Taken:

 OCDRO - 9 is closely monitoring the incident and closely coordinating with the Kumalarang MDRRMO and Zamboanga del Sur Provincial Police Station for other details and for any development.

### II. Initial Report re Fire Incident in Villa España, Victory Avenue, Brgy Tatalon, Quezon City

#### A. Situation Overview:

- On or about 1900H, 22 October 2015, a fire incident occurred in a residential area in Villa España, Victory Avenue, Brgy Tatalon, Quezon City. The fire reached Task Force "A" but was declared under control at around 2105H of the same day.
- · The cause of fire is still under investigation

#### B. Effects:

- About 100 houses and 413 families / 1,805 persons were affected. These affected individuals are currently evacuated at the Victoria Covered Court, Brgy. Tatalon, Quezon City.
- Seven (7) individuals sustained minor injuries:

- One (1) individual, Manuel Claudio, sustained major injury and was admitted at the East Avenue Medical Center

#### C. Actions Taken:

- Quezon City Bureau of Fire Protection (QCBFP), Rescue QC Department of Public Order and Safety (DPOS) and other fire brigade volunteers responded to the incident.
- Quezon City Social Welfare Office is providing relief (food and non-food) to the evacuees
- OCD-NCR coordinating with QCDRRMO for the status of affected families.
