1. Final Report re Fire Incident in Brgy. 73, PNR Compound, Caloocan City (NCR)

A. Situation Overview:

- On or about 1913H 01 November 2015, a fire incident occurred in # 523 PNR Compound, Brgy 73, Samson Road, Caloocan City involving residential houses.
- The fire reached 5th alarm and was declared fire out at 2207H of the same day.
- The origin and cause of fire are yet to be determined.

B. Effects:

- Approximately one hundred (100) families are affected.
- Approximately fifty (50) houses are affected and the estimated cost of damage amounted to PhP1,000,000.00.
- Two (2) persons were injured:
 - ✓ Jose Romero Guarino - 59 yrs old, suffered superficial burn on left arm and forearm;
 - ✓ F02 Ryan Caincol (BFP) – sustained laceration on right hand

C. Actions Taken:

- Caloocan BFP and other fire volunteer brigades responded to the incident.
- Red Cross Recue Medical Team provided first aid treatment and transported burn victim to Caloocan City Memorial Medical Center
- OCD NCR coordinated with Caloocan City BFP for final report.

2. Initial Report re Fire Incident in Brgy 175, Bagong Silang, Caloocan City (NCR)

A. Situation Overview:

- On or about 0533H 02 November 2015, a fire incident occurred in Phase 4B, Package 5, Block 40 Lot 6, Brgy 175, Bagong Silang, Caloocan City involving a two-storey residential structure.
- The fire reached 2nd alarm and was declared fire out at 0622H, same day.
- The cause of fire is an unattended lighted candle in the 2F bedroom of the said structure.

B. Effects:

- One (1) family was affected
- The estimated cost of damage amounted to Php50,000,00.
- Three (3) persons were injured:
 - ✓ Jovencio Cayetano - 43 yrs old, sustained 2nd degree burn on lower and upper body;
 - ✓ Marilyn Cayetano – 41 years old, sustained 2nd degree burn on right arm, leg, back and top of head; and
 - ✓ Beverly Cayetano – 19 year old, sustained minor burn on left hand

C. Actions Taken:

- Caloocan BFP responded to the incident.
 - OCD NCR coordinated with Caloocan City BFP for spot report.
