1. Final Report re Vehicular Incident in Pinabacdao, Samar (Region VIII)

A. Situation Overview:

- On or about 2:00 AM, 31 January 2016, a vehicular incident transpired in Brgy. Lale, Pinabacdao, Samar involving a fuel tanker.
- The fuel tanker **owned by Total Oil and Gas Resources Inc.** was travelling north-bound along the National Highway and upon reaching the descending and curved portion of the road, the driver lost control of the steering wheel that caused the truck to swerve to the side of the road thereby hitting three (3) houses resulting to an explosion.

B. Effects:

- A total of eight (8) casualties were reported in the said accident. Of which, seven (7) were dead and one (1) was injured:

- Three (3) houses were burned, owned by Ms. Gaudencia Tablan, Mr. Romy Balondo and Mr. Arman Balondo.

C. Actions Taken:

- BFP-Pinabacdao responded to the incident.
- MPS-Pinabacdao conducted investigation regarding the incident.
- Pinabacdao MPS, Samar PPO coordinated with Tabango MPS, Leyte PPO to inform the relatives of the passengers**

- A case against Total Oil and Gas Resources Inc. is being prepared for filing
- OCDRO VIII visited the site and in close coordination with PRO8

2. Progress Report re Vehicular Incident in Nasugbu, Batangas (Region IV-A)

A. Situation Overview:

- On or about 6:00 PM, 03 February 2016, a vehicular incident occurred along Brgy. Kaylaway, Nasugbu, Batangas involving 3 vehicles: a trailer truck with plate no. NUZ 325 driven by Emmanuel Sison, a San Agustin Bus with plate no. TYR 891 driven by Clodualdo Sintos y Gomez and a passenger jeepney driven by Benjamin Cruzada with plate number DXB 750.

B. Effects:

- A total of fourteen (14) casualties were reported due to the accident. Of which, 1 was dead and 13 were suffered injuries:
