1. Progress Report re Fire Incident inside the Phoenix Petroleum Depot in the Municipality of Calaca, Batangas

A. Situation Overview:

1. On or about 4:21PM, 20 February 2016, a fire incident transpired inside the Phoenix Petroleum Depot, Calaca, Batangas
2. The fire reached general alarm and still ongoing.
3. The cause of fire is still under investigation.

B. Effects:

1. Two (2) barangays were affected, namely: Salong and Camastilisan with 115 families or 500 persons were affected; **however, 142 families or 559 persons were evacuated** in Calaca Central School, Camastilisan Elementary School, Dacanlao Elementary School & Puting Bato West Elementary School, all of Calaca, Batangas.
2. MDRRMC distributed food packs to the affected families
3. **Two (2) persons were injured and brought to the following hospitals for medical treatment:**

C. Actions Taken:

1. **The following responded in the incident:**
 - ✓ Twenty-Nine (29) BFP IV-A Fire Trucks with 135 personnel
 - ✓ Twenty-nine (29) fire volunteers

- ✓ Nine (9) LGU Fire Trucks
 - ✓ Two (2) Ambulances (LGU Calaca and PRC)
 - ✓ Others groups (DREVAN and WRECKER)
2. OCDRC-IVA is continuously monitoring the incident and closely coordinating with BFP-IVA and BFP Batangas for further updates on the incident.
 3. PDRMO Batangas is in the area to closely monitor and coordinate with the responding agencies.
 4. **PNRC Batangas distributed food packs to the affected families.**
 5. **BFP IV-A alerted all provincial, city, and municipal fire stations and personnel for possible deployment**

2. Initial Report re Fire Incident in Batangas City

A. Situation Overview:

1. On or about 2:35 AM, 21 February 2016, a fire incident transpired in Villa Anita Subdivision, Batangas City
2. The fire reached first alarm and declared under controlled at around 0350H of the same day
3. The cause of fire is still under investigation.

B. Effects:

1. One (1) person reportedly died in the incident identified as RJ Bajar Mendoza, 2 y/o

C. Actions Taken:

1. Batangas City DRRMO coordinated with the BFP and PNP, City's Health Office, Public Information Office, Defense Security Service (DSS), and Social Welfare and Development Office, Philippine National Red Cross Batangas, Meralco, and Batangas City Water District.
 2. Batangas City Department Offices provided basic needs to the affected families such as food and clothing
 3. Batangas City SWD Office conducted psychosocial processing to the fire victims
 4. Batangas City DRRM extended funeral assistance to the dead victim
 5. OCDRC-IVA continuously monitoring the incident and closely coordinating with BFP-IVA and BFP Batangas for further updates on the incident
