1. Belated Report re Vehicular Accident in Santiago, Ilocos Sur (Region I)

A. Situation Overview:

1. On or about 2:00 AM, 07 February 2016, a passenger bus swerved on the other side of the road and hit a couple of trees and crashed to a residential area after the bus driver lost control of the steering wheel due to slippery road in Barangay Olo-Olo Sur, Santiago, Ilocos Sur.

B. Effects:

- A total of two (2) individuals were reported dead and 32 were injured on the incident:

1. DOH-HEMS coordinated with the local police and the MDRRMO Santiago to verify the incident.
2. OCDRO I coordinated with PDOHO Ilocos Sur and MDRRMO Santiago for updates on the incident.

2. Incident Report re Fire Incident in Bacolod City, Negros Occidental (NIR)

A. Situation Overview:

2. At about 8:15 AM, 01 March 2016, a fire broke-out at Purok Riverside, Barangay Banago, Bacolod City, Negros Occidental
3. BFP-Bacolod City is still investigating the cause of fire

B. Effects:

4. A total of seventy-eight (78) houses were damaged. Of which, seventy (70) were totally damaged while eight (8) were partially damaged
5. Approximately 83 families were affected on the incident

C. Actions Taken:

1. Bacolod City Fire Station, Amity Volunteer Fire Brigade, and Chamber Volunteer Fire Brigade immediately responded to the incident
