1. Progress Report re Diarrhea Cases in Eastern Visayas (Region VIII)

A. Situation Overview:

 OCD VIII received report from DOH-HEMS on 09 June 2016 about diarrheal cases in Eastern Visayas from 01 April - 08 June 2016 due to intake of contaminated food and water which coincided with the occurrence of El Niño where dry spell caused water scarcity experienced in highland communities.

B. Effects:

 As of 15 June 2016, 5:00 PM, a total of 3,669 cases were reported from hospitals and Rural Health Units (RHUs) in the Provinces of Samar, Eastern Samar, Northern Samar, and Leyte:

Samar: 1,836 casesLeyte: 370 cases

Northern Samar: 940 casesEastern Samar: 523 cases

 A total of 44 persons were reported dead due to hypovolemic shock secondary to severe dehydration:

C. Actions Taken:

1. RDRRMC VIII

OCD VIII

- Attended and participated in the meeting and discussion with DOH Team to help address the increasing number of diarrhea cases in Eastern Visayas held at DOH, Palo, Leyte.
- Attended the dialogue with DOH and affected Local Government Units (LGUs) in the Province of Samar held at the Provincial DOH Office, Catbalogan City, Samar.
- Attended the press conference and addressed the queries regarding the possibility of declaration of State of Calamity by the affected LGUs.
- Attended the Water, Sanitation, and Hygiene (WASH) Cluster Meeting and identified logistical requirements for the identified short-term action plans.
- Coordinated with DOH Regional Office VIII (DOH-RO VIII) for updates and harmonization of data.
- Coordinated with the Philippine Red Cross (PRC) and DOH-RO VIII to discuss the mobilization plan for the deployment of water treatment units.
- Provided 200 liters of fuel for the initial consumption of the water treatment units to be provided by PRC.
- Attended the meeting with Northern Samar PDRRMO, DSWD, DOH, DILG, 803rd Brigade of the AFP, and members of the media in Northern Samar and discussed therein were updates on the increasing diarrheal cases in the province.
- Informed the public regarding the latest update in the diarrheal cases and advocated for the health advisory through the local radio station 91.7 Like Radio.

DILG VIII

- Attended the WASH Cluster Meeting.
- Pledged to provide the list of municipalities with "SALINTUBIG" Projects.

DOH-RO VIII

- Raised to Code White Alert in anticipation for the further increase of the said outbreak and advised the public to ensure usage of safe and clean water, observe proper hand washing, and clean food preparation.
- Regional Epidemiology and Surveillance Unit (RESU) conducted investigation and collected samples of laboratory confirmation.
- Regional HEMS (RHEMS) VIII provided IV fluids, assorted medicine, and aquatabs to Calbiga, Samar, and Catarman, Northern Samar amounting to ₱34,497.15.
- Samar, Eastern Samar, and Northern Samar Provincial DOH Offices coordinated with RHU and LGUs for continuous monitoring.
- RESU conducted health education regarding the importance of early consultation and importance of hydration before cases are brought to health authorities.
- RHEMS augmented Oral Rehydration Salt (ORS) worth ₱18,000.00 and 200 boxes of aquatabs donated by UNICEF to Jipapad RHU.
- Conducted planning and debriefing for DOH-RO VIII Response Team 4 on 08 June 2016.

- Submitted HEARS field report to authorities and partners.
- Organized a press conference to raise public awareness and disseminate the information to the affected provinces.
- Convened the WASH Cluster of Region VIII to update the regional partners on the situation and identify the need for possible assistance.
- Advised the public to observe the following to prevent the spread of the disease:
 - 1. Ensure usage of safe and clean water.
 - 2. If unsure, boil water for three minutes.
 - 3. Proper hand washing and hygiene.
 - 4. Proper food preparation.
 - 5. Practice household water treatment with chlorine, aquatabs, and hyposol.
 - 6. Storage reservoirs and water tanks should be regularly cleansed.
 - 7. Seek early consultation and use of ORS at home before sending the patient to the RHUs / hospitals.

BFP VIII

 Attended the WASH Cluster Meeting and pledged to supply water for household use in affected barangays in Leyte.

PHILHEALTH VIII

 Attended the WASH Cluster Meeting and pledged to provide exception to the 3-day confinement rule for the patients to avail reimbursement claims.

PHILIPPINE INFORMATION AGENCY (PIA) VIII

- Convened the local media and organized press conferences.
- Disseminated information to different stakeholders.

PRC VIII

• Attended the WASH Cluster Meeting and provided three (3) water treatment units with manpower to be deployed to Samar and Northern Samar.

OXFAM

 Attended the WASH Cluster Meeting and provided 1,000 jerry cans, 2,000 bottles of hyposol, and IEC materials regarding preparation of hyposol worth ₱267,200.00 prepositioned in Calbiga, Samar.
