1. Report on the Drying up of Water Wells in Sto. Domingo, Albay from OCDRC5

A. Situation Overview:

- Due to adverse impact prolonged drought, the Municipality of Sto. Domingo, Albay is
 experiencing shortage of water supply due to cases of drying of wells on the vicinity.
- Moreover, the depletion of several water wells and springs were due to the likely inflationary trend shown by the electronic tilt located along the upper slope of Mayon volcano based on the on-going evaluation.
- Sto. Domingo declared a State of Calamity on Sept. 20, 2016 to mitigate the impending effects of the situation.

C. Actions Taken:

- OCD5 coordinated with APSEMO and LGU/MDRRMO of Sto. Domingo and is continuously monitoring the incident
- LGU Sto. Domingo declared State of Calamity thru SB Resolution No. 072-2016.
 - Conducted water rationing (domestic water) using local BFP and delivered potable water using Provincial Government Watsan and Lorry.
 - o Received donation (domestic water) from Tobaco City iusong BFP Tabaco.

2. Progress Report re Fire at Brgy. Don Bosco, Parañaque City from OCDNCR

A. Situation Overview:

 Fire incident reported on or about 211605H September 2016 at Surigao St, Pagibig sa Kapwa, Malacanang Dulo, Parañaque City that reached third alarm at 1620H but was declared "Fire out" at about 1803H same day.

B. Effects:

- Estimated damage to property = PhP 1,000,000 more or less
- 40 more or less families affected
 - Affected families evacuated at Annex 34 Felicity, Brgy. Don Bosco
 - Local social weflare on-site are processing and providing relief assistance
- 40 houses totally damages and 6 houses partially damaged

D. Actions Taken:

 OCDNCR coordinated with Parañaque BFP and CDRRMO and submitted report to NDRRMC OpCen.

3. Initial Report re Fire at Brgy. San Roque, Marikina City from OCDNCR

A. Situation Overview:

 Fire incident reported on or about 230227H September 2016 at 160 A Dela Paz, Brgy. San Roque, Marikina City that reached first alarm at 0227H but was declared under control at 0238H and "Fire out" at about 0309H same day.

B. Effects:

- One family affected
- One two-storey residential structure was involved

- 6 person was reported dead to include Gabriela Gatchalian, Justin San Juan, Bryan San Juan, Samanta Alvarado, Savana Alvarado, Allan Alvarado. No report of injured or missing as of reporting.
- Arson investigation on-site to provide detailed information of reported casualties.

E. Actions Taken:

- OCDNCR coordinated with Marikina BFP and CDRRMO and requested spot report.
- Requested validation and confirmation of casualties from DILG-NCR.
- Submitted initial report to NDRRMC OpCen with progress report to follow.

4. Initial Report re Pre-emptive Evacuation at Tumawas Village, Brgy Halapitan, San Fernando, Bukidnon from RDRRMC X

A. Situation Overview:

 Pre-emptive evacuation was conducted at around 9:10 PM 23 Sept. 2016 at Tumawas Village, Brgy Halapitan, San Fernando, Bukidnon due to high water-level rise at Tigwa River.

B. Effects:

- 27 families or 80 persons were affected fromTumawas Village, Brgy Halapitan, San Fernando, Bukidnon who are staying at San Fernando Municipal Gymnasium.
- Estimated Damages still to be determined.

C. Actions Taken:

- LDRRMO responders, BFP, and Brgy. Volunteers immediately conducted rescue operations.
- Municipal Health Officers assisted the affected individuals
- LGU San Fernando distributed blankets and safe drinking water to the evacuees
