1. Report on Flashflood in Brgy. Sumbakil, Polomolok, South Cotabato (Region X)

A. Situation Overview:

- On 11 October 2016 at 3:00 PM, heavy rainfall was experienced in Brgy. Sumbakil, Polomolok, due to thunderstorm that caused the water level in the Sumbakil Creek to rise

B. Effects:

- Eight (8) families were affected:
 - Three (3) families located along the creek were evacuated to safe areas
 - Five (5) families remained to their homes
- At 10:00 PM on the same day, flood water already subsided and the three (3) families were assisted back to their respective home

C. Actions Taken:

- MDRRMO Search and Rescue Group responders were deployed
- MDRRMO provided food and water
- MDRRMC and BDRRMC conducted ocular inspection
- Municipal Engineering Office deployed bulldozer equipment to conduct immediate rehabilitation/re-trenching of the creek/waterway

2. Initial Report re Noise Barrage at Manila City Jail (NCR)

A. Situation Overview:

- At around 10:20 AM, 13 October 2016, around 600 members of Batang City Jail held a noise barrage at the Manila City Jail Dormitories 9 and 10

- Approximately 300 members went on top of the roof to air their sentiments and opposed the new measures implemented by the management to merge all detainees regardless of gang affiliation
- Detainees became unruly and started throwing objects on the jail guards. The commotion escalated that prompted augmentation from MPD DPSB and SWAT

B. Effects:

- As a result, four (4) BJMP Jail Guards and thirty-five (35) Detainees were injured:
