BASIN AVERAGE RAINFALL:

PAST 24-HR RAINFALL: 15MM

FORECAST FOR THE NEXT 12-HOURS: LIGHT TO MODERATE

WATERCOURSES LIKELY TO BE AFFECTED:

- UPPER MAIN CAGAYAN RIVER particularly GANANO, MAGAT, AND SIFFU
Flooding is Possible in the low lying areas of ECHAGUE, JONES, ANGADANAN, ALICIA and CAUAYAN.
- MIDDLE MAIN CAGAYAN RIVER particularly PINAGCANAUAN RIVERS, TUMAINI and SAN PABLO.
Flooding is Possible in the low lying areas of NAGUILIAN, GAMU, ILAGAN, TUMAINI, DELFIN ALBANO, STO.TOMAS, CABAGAN STA.MARIA and SAN PABLO.
- LOWER MAIN CAGAYAN RIVER particularly PINAGCANAUAN RIVERS, TUMAINI and SAN PABLO.
Flooding is Possible in the low lying areas of TUGUEGARAO CITY, ENRILE, TUAO, SOLANA, IGUIG, AMULUNG, ALCALA, GATTARAN, LALLO, LASAM, BAGGAO, CAMALINIUGAN and APARRI.

PUBLIC WARNING:

PEOPLE LIVING NEAR THE MOUNTAIN SLOPES AND LOW-LYING AREAS NEAR THE ABOVE MENTIONED RIVERS AND THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCILS CONCERNED ARE ADVISED TO TAKE PRECAUTIONARY MEASURES.


You are hereby directed to undertake monitoring of precautionary measures in your AOR. Likewise, the public and DRRMCs concerned are advised to take appropriated actions.

Conduct press briefings often as needed. This local effort will complement and reinforce efforts at the national level. Emphasis should be on proactive actions – evacuation rather than rescue.
