#### I. OVERVIEW

President Rodrigo Roa Duterte, issued Proclamation No. 319, declaring 21 September 2017 as a National Day of Protest, in solidarity with the people's call against all excesses and shortcomings of the government, and with the people's desire to uphold the highest standards of integrity, efficiency, and accountability in government.

In this view, Memorandum Circular No. 26 was issued, suspending work in government offices, both national and local, and classes in public schools in all levels, including state universities and colleges. However, the suspension of work in private companies and classes in private schools in affected areas are left to the sound discretion of their respective heads.

Further, the City Government of Manila is anticipating massive demonstrations both from anti-government and pro-government supporters particularly in the vicinity of Welcome Rotonda, España, Mendiola, B. Bustillos, Plaza Miranda, and the US Embassy. Over 20,000 people are expected to join in the protest actions while at least 15,000 people are expected to join the pro-administration program in Mendiola and Plaza Miranda in Quiapo.

# II. WEATHER CONDITION

# A. Weather Outlook (20-22 September 2017)

Humid weather condition is expected over most parts of Northern Luzon due to Ridge of High Pressure Area (HPA) which will prevail over extreme Northern Luzon.

Improved weather is likely to be experienced over the rest of the country causing the whole archipelago to have partly cloudy to at times cloudy skies with isolated rainshowers or thunderstorms. This weather scenario is expected to persist until Friday, 22 September 2017.

#### III. MONITORED ACTIVITIES

# 21 September 2017 (Thursday)

#### 11:10 AM

- a. Vehicles reportedly owned by the protesters/demonstrators were lined up outside Camp General Emilio Aguinaldo, near Gate 2 along EDSA.
- b. A stage was established in the center island of Roxas Boulevard fronting the Jose Rizal Monument (Luneta).

#### 12:49 PM

a. A pro-government assembly was staged at Plainview Elementary School, Mandaluyong City, which then proceeded to Plaza Miranda.

#### 1:00 PM - 1:30 PM

- a. An estimated 100 protesters gathered in front of Bantayog Ng Mga Bayani along EDSA.
- b. An anti-government group of about 1,500 protesters were within the University of Santo Tomas and headed to Quirino/Mendiola.
- c. At about 1:30 in the afternoon, an estimated 6,000 protesters gathered at Mendiola.

#### 4:05 PM - 5:17 PM

- a. At about 4:05 PM, the pro-government assembly was estimated to be around 3,500 in Mendiola while the anti-government assembly at Plaza Miranda was estimated to be around 4,000.
- b. At about 4:06 PM, the anti-government group moved towards Roxas Boulevard.
- c. At about 5:17 PM, police were already in place/on standby in anticipation for the arrival of the protesters/demonstrators.

#### 6:30 PM - 7:25 PM

- a. As of 6:30 PM, Mendiola and Plaza Miranda were already cleared of protesters except in the Luneta area.
- b. Around forty (40) pro-government individuals was seen in front of San Beda College.
- c. Around 1,000 rallyist were organized in front of the Commisssion on Human Rights (CHR) in UP Campus.
- d. At about 7:25 PM, an estimated 3,000 protesters were in Luneta (Quirino).

#### 8:00 PM - 9:00 PM

- a. At 8:00 PM, protesters/demonstrators in front of CHR in UP Campus decreased to only 200 persons.
- b. At about 8:30 PM, between 200 to 300 protesters/demonstrators remained at the Luneta area.
- c. The program ended at around 9:00 in the evening.

#### III. EFFECTS

# A. SUSPENSION OF CLASSES AND WORK

Through Memorandum Circular No. 26 dated 19 September 2017, the Office of the President declared suspension for work in government offices, both national and local, and classes in public schools at all levels, including state universities and colleges.

A number of private schools also suspended their respective classes.

#### IV. PREPAREDNESS MEASURES

#### A. NATIONAL / NDRRMC

### 1. NDRRM Operations Center (NDRRMOC)

- a. The NDRRMOC raised its alert status to Blue effective 5:00 PM 20 September 2017 to monitor and coordinate all efforts to ensure safety and security of the public.
- b. Representatives from AFP, PNP, BFP, and PCG rendered duty at the NDRRMOC as Detailed Duty Officers (DDOs) to ensure continuous coordination.

# 2. Bureau of Fire Protection (BFP)

- a. Activated to Red Alert Status on 20 September 2017.
- b. Placed on standby for emergency assistance near protest sites and areas of mass action.

# 3. Philippine National Police (PNP)

- a. Offices and Units are at full alert.
- 4. Armed Forces of the Philippines (AFP)

- a. Released directive for additional tactical forces to augment JTF-NCR in connection with the upcoming commemoration of the declaration of Martial Law.
- b. Philippine Navy released control of two (2) CDM Companies with mobility and provisions to JTF-NCR effective 20 September 2017.
- c. Headquarters Philippine Navy and Headquarters Support Group provided one medical team with ambulance on standby at headquarters of the Philippine Navy.
- d. SOLCOM and NOLCOM Barangay Patrol Team (BPT) released operational control of one (1) Infantry Battalion to JTF-NCR.

- a. In normal deployment but in full alert for possible emergency assistance with standby units for crowd management.
- b. Closely monitoring their area of responsibility for appropriate coordination, communication, report development and possible actions to be taken.

# Philippine Information Agency-Cordillera (PIA-CAR)

- a. Continuously covering/documenting significant events related to the National Day of Protest and other mass gatherings in the Cordillera Administrative Region especially in Baguio City.
- b. Closely monitoring the area of responsibility for appropriate coordination, communication, report development, and possible actions to be taken.

# LDRRMCs Abra, Apayao, Benguet, Baguio City, Ifugao, Kalinga, Mt. Province

- a. Manning their respective DRRM EOCs and in continuous monitoring of the situation within their respective AORs for appropriate coordination, communication, report development, and possible actions to be taken.
