I. SITUATION OVERVIEW

11 October 2017

At 10:00 PM, the Low Pressure Area (LPA) Northeast of Borongon City, Eastern Samar has developed into a Tropical Depression (TD) and was named "ODETTE". It has maximum sustained winds of 45 kph near the center and gustiness of up to 60 kph. It was forecasted to move West Northwest at 26 kph.

Tropical Cyclone Warning Signal (TCWS) No. 1 was raised over Cagayan and Isabela.

12 October 2017

At 4:00 PM, the center of TD "ODETTE" has maintained its strength and posed threat to Cagayan Province.

TCWS No. 1 was raised over Batanes, Cagayan including Babuyan Group of Islands, Isabela, Apayao, Abra, Kalinga, Mountain Province, Ifugao, Ilocos Norte and Ilocos Sur.

At 10:00 PM, "ODETTE" has intensified into a Tropical Storm (T\$).

TCWS No. 2 was hoisted over Batanes, Cagayan including Babuyan Group of Islands, Apayao, and Ilocos Norte.

13 October 2017

At 12:40 AM, TS "ODETTE" has made landfall over Santa Ana, Cagayan.

At 4:00 AM, TS "ODETTE" has slightly intensified as it continued to traverse Northern Cagayan.

At 10:00 AM, the center of TS "ODETTE" was estimated based on all available data at 45 km West of Sinait, Ilocos Sur with maximum sustained winds of 75 kph near the center and gustiness of up to 100 kph. TCWS No. 2 was hoisted over Batanes and Babuyan Group of Islands while TCWS No. 1 was issued over the Province of Cagayan.

At 11:00 PM, "ODETTE" has maintained its strength and was located over the West Philippine Sea. Tropical Cyclone Warning Signals elsewhere were already lifted.

14 October 2017

At 4:00 AM, its center was estimated based on all available data at 280 km West Northwest of Dagupan City, Pangasinan with maximum sustained winds of 90kph near the center and gustiness of up to 115 kph. It was forecasted to move West Northwest at 10 kph.

At 11:00 PM, STS "ODETTE" exited the Philippine Area of Responsibility (PAR). It is forecasted to move Northwest at 15 kph with a maximum sustained winds of 110 kph near the center and gustiness of up to 140 kph.

II. EFFECTS

1. At the height of the event a total of seventeen (17) passengers and five (5) motor bandas were reported stranded in Aparri and Basco (Region II). As of 16 October 2017, all shipping and fishing companies have resumed with their normal operations.

- a. Raised the alert status to BLUE effective 12:00 NN, 12 October 2017.
- b. Conducted Emergency Response Preparedness (ERP) re Severe Tropical Storm "ODETTE" on 12 October 2017, 10:00 AM.
- c. Issued NDRRMC Memorandum to RDRRMCs I II, III, and CAR re Submission of RDRRMC's Preparedness Actions in relation to Severe Tropical Storm "ODETTE".
- d. Issued NDRRMC Memorandum to NDRRMC Member-Agencies re the Alert Status at the NDRRMOC.
- e. Prepared Emergency Alert and Warning Messages (EAWM) re STS "ODETTE" and forwarded the same to Telecommunications Service Providers for widest dissemination to the public.
- f. Continuously disseminates Severe Weather Bulletins, General Flood Advisories, Gale Warnings, and Flood Bulletins to RDRRMCs/OCDROs concerned through SMS, facsimile, and official social media websites for further dissemination to their respective Local Disaster Risk Reduction and Management Councils (LDRRMCs).

2. Philippine Atmospheric, Geophysical and Astronomical Services Administration (DOST-PAGASA)

- a. Provided updates on the track of the said weather disturbance and Status of monitored major dams during the ERP Meeting on 12 October 2017.
- b. Continuously disseminates Severe Weather Bulletins, General Flood Advisories, Flood Bulletins and Gale Warnings re Severe Tropical Storm "ODETTE".

3. Department of Interior and Local Government (DILG)

- a. Provided information/advisories to all concerned DILG ROs regarding the development of the STS "ODETTE" thru emails and text blasts.
- b. Instructed all concerned DILG ROs to take proactive measures in the impending disaster.
- c. Provided updates on weather alerts/advisories to all ROs and LGUs.
- d. Advised all concerned DILG Regional Office to activate the DILG Regional Disaster Reporting and Monitoring for STS "ODETTE".
- e. Continuous monitoring of all affected LGUs.
- f. Advised Regional Offices of I, II, III, and CAR on the updates of STS "ODETTE" to activate their disaster monitoring and reporting systems.
- g. Disseminated information to concerned field offices on the list of barangays with greater than 10a0 mm rain and barangays with high to very high susceptibility to floods and landslides from PAGASA and MGB.
- h. Alerted and advised all concerned LGUs to perform the following actions:

- Initiate critical preparedness actions based on the Operation L!STO protocols, and prepare communities especially those in low-lying and/or landslide prone areas, highways, and riverbanks, including fishermen
- Activate concerned Barangay DRRMCs for early warning measures and vigilant monitoring of areas with settlements at the base of sliding slopes or ridges with manifestations of rockslide/landslide, tension cracks, and areas identified as very high/critical landslide zones
- Vigilant monitoring and reporting of the impending weather disturbances and other incidents during this holiday season
- Continuously inform/advise all communities thru but not limited to the local television channels and radio stations of the updates of the situation and preparedness actions of the localities
- Vigilant monitoring of levels of river water and settlements in lowlying areas or near riverbanks which have experienced recent and repeated flooding
- Vigilant monitoring for possible riverbank eros on and shift of river flow direction
- Prepare to implement evacuation protocol in areas with high susceptibility ratings to landslide and flood

- a. All CG stations and substations are advised to ensure strict implementation of Guidelines on the movement of vessels during heavy weather (HPCG Memo Circular 01-09) and in the absence of weather bulletin in the locality (HPCG Memo Circular 03-01).
- b. Deployable Response Groups (DRGs) are placed on standby status 24/7.
- c. Assets are placed on standby status ready for deployment on flood prone and coastal areas.
- d. All Coast Guards Stations and Sub-Stations closely monitor weather forecast.
