I. SITUATION OVERVIEW

The All Saints' Day and All Souls' Day are celebrated by Filipinos every 01 November and 02 November of the year to pay respect to beloved dead relatives and friends.

On this annual commemoration of "UNDAS", millions are expected to travel to their respective provinces and expected to flock cemeteries around the country as a long holiday is anticipated.

II. CURRENT WEATHER SITUATION

At 3:00 AM, 02 November 2017, the center of Tropical Depression "RAMIL" was estimated based on all available data at 210 km West of Coron, Palawan (12.2°N, 118.3°E) with maximum sustained winds of 55 km/h near the center and gustiness of up to 65 km/h. It is forecast to move West at 15 km/h. Northeast Monsoon affecting Northern Luzon.

TD "RAMIL" will cause cloudy skies with scattered to widespread rains and thunderstorms over MIMAROPA and the provinces of Aurora and Quezon, and cloudy skies with scattered rains and thunderstorms over Metro Manila, the regions of Cagayan Valley, Cordillera, the rest of Central Luzon and of CALABARZON. Possible lightning and moderate to occasionally heavy rains which may cause flooding/landslides.

Ilocos Region will experience cloudy skies with light rains due to the Northeast Monsoon while Visayas and Mindanao will experience partly cloudy to cloudy skies with isolated rainshowers or thunderstorms caused by the localized thunderstorms. Possible isolated lighting, strong winds, and occasional heavy rains.

Moderate to strong winds blowing from east to southeast will prevail over Palawan, the rest of Luzon, Visayas, and eastern section of Mindanao. Coastal waters will be moderate to rough. Light to moderate winds blowing from east to southeast will prevail over the rest of Mindanao. Coastal waters will be slight to moderate.

III. EFFECTS

A. Incident Monitored

- a. At 3:42 PM, 30 October 2017, a vehicular accident involving white Montero occurred at Halsema Road, Abiang, Atok, Benguet. The vehicle with plate number PEO 782 driven by a certain Dr. Milvin Mercado Ambal, 48 years old, physician, and a resident of San Jose, Batangas was heading to Baguio City when he allegedly felt unusual movement on the rear wheels, loses break and bumped into the road parapet. No casualty reported.

B. Status of Ports

- a. As of 02 November 2017, 12:00 AM, a total of 27,574 outbound passengers and 22,645 inbound passengers were monitored by all PCG Districts.

IV. DISASTER PREPAREDNESS

A. National Disaster Risk Reduction and Management Council

1. NDRRM Operations Center (NDRRMOC)

- a. Disseminated the Memorandum regarding the Annual Commemoration of All Saints' Day and All Souls' Day to NDRRMC Member Agencies on 30 October 2017 wherein the NDRRMC Member Agencies particularly those responsible for safety, transport security, health emergency, peace and order are reminded to review and activate their respective contingency plans to avert impending hazards to the populace.
- b. Alert status at the NDRRM Operations Center was raised to Blue Alert effective 8:00 AM, 31 October 2017 relative to "ALERTO UNDAS 2017" for prompt coordination, monitoring, and reporting, to provide decision-makers, the public, and all concerned stakeholders with valuable information.

2. Bureau of Fire Protection (BFP)

- a. On Heightened Alert status from 27 October to 02 November 2017.
- b. Directed all fire stations to conduct community information drive that includes distribution of fire safety materials from 27 October to 02 November 2017.
- c. Fire truck visibility in which they are also used as public address system on fire safety precautions.
- d. Intensified fire safety inspection on all transport stations/terminals, mortuary chapels, columbaria, cemeteries and other places of assembly.
- e. Deployed personnel and firefighting apparatus, ambulances, and Emergency Medical Services (EMS) to visible points of public gathering and assembly.

3. Philippine National Police (PNP)

- a. Issued a memorandum reminding all operating units of the Full Alert status in the observance of All Saints' and All Souls' Day 2017.
- b. Directed all personnel to be ready and on-call.

4. Philippine Coast Guard (PCG)

- a. Implemented *Oplan Biyaheng Ayos* from 26 October to 06 November 2017 to ensure the orderly operation of sea transport facilities and safe travel of seafaring public.

5. Armed Forces of the Philippines (AFP)

- a. Joint Task Force NCR conducts security and support operations to support NCRPO in order to ensure secure, safe, and peaceful observance of All Saints' and All Souls' Day in the National Capital Region.
- b. One Platoon from 3rd JFC, Coy, 2ID, PA conducted visibility patrol in Cubao, Quezon City in coordination with PNP personnel.
- c. One Squad from 3rd JFC, Coy, 2ID, PA conducted area security at Old Terminal, Araneta Center, Cubao Quezon City.
- d. Deployed personnel in a number of cemeteries around Metro Manila.

B. Regional / Local Disaster Risk Reduction and Management Councils (R/LDRRMCs)

- a. RDRRMCs I, II, **III, CALABARZON**, V, **VI, VII, IX**, XII, ARMM, CARAGA, CAR, and NCR placed their respective Operations Center under alert status and implemented the ALERTO UNDAS 2017 for prompt coordination, monitoring, and reporting of UNDAS-related incidents; disseminates timely and safety advisories and closely coordinates with RDRRMC Member Agencies, Provincial/City/Municipal DRRMCs (P/C/MDRRMCs), local and media practitioners utilizing all means of communication (InfoBoard-SMS, internet, email, social media network, facsimile, others), for possible rescue, relief, and other response operations relative to UNDAS-related incidents; and continuously monitors the situation in their respective Areas of Responsibility (AOR) and ready to provide assistance as needs arises.

- a. Alerted all provincial, city, and municipal offices to closely coordinate with LCEs, Chief of Police, fire marshals, and other concerned authorities for strict enforcement of protocols.

DSWD - CALABARZON

- a. DSWD Disaster Management Unit is already on heightened alert together with the Quick Response Teams.
- b. Ensured the availability of funds and family food packs that may be given to victims if disaster occurs. Stockpiles composed of food and non-food items have been prepared at the field office and at the warehouses of the five provinces of the region.
- c. The local Social Welfare and Development Officers in the region were advised to closely coordinate with their respective Chief of Police, Bureau of Fire Protection, MDRRMOs, and other emergency response groups for their plans and preparations in relation to Oplan Undas 2017.

DOH - CALABARZON

- a. DOH retained hospitals and Centers for Health Development were activated to Code White Alert on All Saints' and All Souls' Day for any eventualities that may arise.
- b. The Health Emergency Management Staff operations center will be on alert on November 1 and 2 to monitor any health or health related emergencies.

DPWH - CALABARZON

- a. Issued a memorandum to District Engineering Offices to identify areas to be manned by assigned personnel for Lakbay Alalay.
- b. Issued a memorandum to advise all contractors to ensure the safety of the public by providing enough safety equipment and signage along national roads leading or near the cemeteries.
- c. Ensured all national highways are maintained and always kept in good shape for safer travel and uninterrupted flow of traffic.

PCG-Southern Tagalog and National Capital Region

- a. Strict observance of heightened alert during Oplan Ligtas Biyahe: Undas 2017.

Continuous coordination with local PNP, AFP, PPA, and shipping companies to emphasize commitment to security and safety in water transport services by enforcing safety standards and regulations such as inspection of baggage and implementation of security layers in ports and passenger terminals to prevent hostile elements from perpetrating terrorist acts and to strictly ensure no overloading of passengers.

- a. Ensures the provision of security coverage and other public safety services during the activity.
- b. Implements active defense against lawless armed groups who may perpetrate violent activities against lightly defended installations.
- c. Enhanced police presence through foot and mobile patrols in areas frequented by the general public, such as malls, train tracks stations, and other transport facilities and terminals (bus stations, airports, and seaports), cemeteries, churches, resorts, and other areas vulnerable to terrorist hostile activities in coordination with other concerned law enforcement agencies, LGUs, and private security providers.
- d. Deployed Road Safety Marshals in strategic areas along the routes to and from cemeteries and other areas of convergence.
