1. SITUATION OVERVIEW:

"Vinta has slightly intensified as it continues to track westward over the Sulu Sea.

- **Scattered to widespread moderate to heavy rains** will prevail over Palawan, while **scattered light to moderate with at times heavy rains** is expected over Bicol region, Visayas, Mindanao and the rest of MIMAROPA within 24 hours.
- Residents of these areas must take appropriate actions against flooding and landslides, coordinate with their respective local disaster risk reduction and management offices, and continue monitoring for updates.
- Sea travel is risky over the seaboard of areas under Tropical Cyclone Warning Signal (TCWS), the southern seaboard of Mindoro provinces and the western seaboard of Aklan and Antique due to the Tropical Storm.

Location of eye/center	At 4:00 AM today, the center of Tropical Storm "VINTA" was estimated based on all available data at 165 km North Northwest of Zamboanga City, Zamboanga del Sur (7.9°N, 121.0°E)
Strength	Maximum sustained winds of up to 75 kph near the center and gustiness of up to 90 kph
Forecast Movement	Forecast to move West at 20 kph
Forecast Positions	24 Hour (Tomorrow morning): 275 km Southwest of Puerto Princesa City, Palawan (8.3°N, 116.7°E) 48 Hour (Monday morning): 390 km Southwest of Pagasa Island, Palawan (OUTSIDE PAR) (8.9°N, 111.3°E)

Most banana plants, a few mango tress, ipil-ipil and similar types of trees are downed or broken. • Some coconut trees may be tilted with few others broken. • Rice and corn may be adversely affected. • Considerable damage to shrubbery and trees with some heavy-foliaged trees blown down.
