I. Progress Report : Food Poisoning in La Union

A. Situation Overview

- On February 15, 2018, a food poisoning was monitored at Sacred Heart School, Bgy. Central East, Bauang, La Union.
- There were **eleven (11)** person who experienced abdominal pain associated with persistent vomiting, headache and body malaise after eating beef tapa from the common source. All were referred to Ilocos Training and Regional Medical Center (ITRMC), San Fernando City, La Union for further treatment and management.
- On February 16, 2018, all the victims were discharged to the said hospital.

II. Progress Report : Vehicular Accident in Naguillan, La Union

A. Situation Overview

- At around 1:20 PM, 22 February 2018, a vehicular accident transpired along Baguio-Bauang Road in the vicinity of Barangay Bato, Naguillian, La Union. While traversing said road, the mini-bus experienced mechanical failure which resulted it to sweep off road towards the rice field and hit the acaia tree.
- On board the vehicle are 29 passengers, including its driver. All were rushed to Naguillian District Hospital and were treated as out-patient
