Belated Report re Armed Conflict in Dalimdim, Brgy. Kapatagan, Compostela Valley Province (Region XI)

A. Situation Overview

On April 19, 2018 around 7:00am, an armed conflict incident occurred in Dalimdim, Brgy. Kapatagan, Compostela Valley Province. The residents evacuated in Kapatagan Elementary School while others preferred to stay with their relatives and friends at Sitio New Bantayan, Purok 11, Brgy. Kapatagan to avoid the possible encounter between the Government Troops and the New People's Army (NPA).

On April 20, 2018 around 11:00am, the clash between two groups ceased. Based on the recent information, there are three (3) additional members from the government Troops that were injured.

B. Effects

C. Actions Taken

LGU of Laak

- As of writing, distributed family food packs to the Internally Displaced Persons (IDPs); Additional Services like medicine assistance, surplus clothing's and hot meals were also provided.
- All MDRRMCs are closely monitoring their respective AOR.

OCD XI

- As of writing there is no need for intervention on a Regional Level.
- Continuous monitoring of AOR for any incident.

Initial Report re Fire Incident in Manila City (NCR)

A. Situation Overview

- At around 1915H, 27 April 2018, a fire incident occurred at a residential area at Oroquieta corner Lope De Vega, Brgy 312, Manila City. The cause of fire is still under investigation.
- At 2026H, the fire reached Task Force Bravo as was fired out at 0310H.
