I. Vehicular Accident in Talisay City, Negros Occidental (REGION VI)

A. SITUATION OVERVIEW

- At 3:30 PM, 31 July 2018, a vehicular accident occurred at Silay-Talisay Access Road, Hda. Matabang, Talisay City, Negros Occidental. A total of five (5) vehicles were involved in the accident.

B. EFFECTS

- A total of eleven (11) persons were reported injured.

C. ACTIONS TAKEN:

PDRRMC Negros Occidental

- Disseminated information thru email and trimedia
- DMPD OpCen disseminated the damage report to concerned agencies
- On standby and is continuously coordinating.

II. Belated Report: Fire Incident in Purok Sto. Niño 1, Brgy. Central, City of Mati, Davao Oriental (REGION XI)

A. SITUATION OVERVIEW

- At 4:35 PM, 24 July 2018, a fire incident occurred in Purok Sto. Niño 1, Brgy. Central City of Mati, Davao Oriental. The said incident was declared fire out at 5:30 PM.

B. EFFECTS

- Five (5) houses were reported totally damaged while two (2) are partially damaged with total of eight (8) families or forty (40) individuals affected.
- One (1) person sustained minor burn injury.

- No reported deaths.

C. ACTIONS TAKEN:

- BFP together with Mati CDRMO, PEEMART, DREAMS and fire volunteers conducted fire suppression.
- Philippine Red Cross distributed sleeping kits to affected families.
- Davao Oriental PSWDO provided half sack of rice, hygiene kits, sleeping kits and food packs to affected families.
- Provision of financial assistance to the fire victims is being processed by Mati CDRMO.
- OCD Region IX coordinated with Davao Oriental PDRMO and Mati CDRMO for situation updates.
- The DSWD-FO IX will also provide sleeping kits, collapsible water jug with purifying tablets, and kitchen utensils.
- The PDRMC-Sulu prepared a total of 3,500 sacks of rice intended to be distributed to the affected families.
- OCD ARMM is continuously monitoring the said incident.

III. Fire Incident at Sitio Kausawagan, Basak Pardo and Sitio Niño , Kinasang-an Pardo, Cebu City (REGION VII)

A. SITUATION OVERVIEW

- At about 9:57 PM on 27 July 2018, a fire incident occurred at Sitio Kausawagan, Basak Pardo and crossed to a neighboring Sitio Niño, Kinasang-an Pardo, Cebu City involving residential houses made mostly of light materials.

B. EFFECTS

- A total of 127 houses were razed by fire.
- A total of 221 families / 982 persons were affected by the incident.
- No reported injuries.

C. ACTIONS TAKEN:

- Fire victims were temporarily sheltered at Villa Zacate Gym and Brgy. Kinasang-an Gym.
- OCD Region VII coordinated with the Bureau of Fire Protection, DSWD Regional Office VII and Cebu City DRRMO re: the fire incident at Sitios Kausawagan and Basak Pardo, Cebu City.
- Cebu City's Department of Social Welfare Services have already distributed packed meals to the fire survivors. Each family received disaster kits worth Php 2,000.00
- City government also will be giving Php 20,000.00 cash aid to owners of totally damaged houses whereas those that were partially damaged will be entitled to Php 10,000.00 worth of financial assistance.
- Private groups such as McDonalds and Cebu Riders Club extended assistance to fire victims.
- Office for the Presidential Assistant for the Visayas (OPAV) distributed relief goods from private donations extended to the office of SAP Bong Go.
- DSWD FO VII continuously coordinates with the city government thru DSWS for any request for augmentation.
- Cebu City DRRMC endorsed a re-blocking scheme on the affected areas.
